



### W8.1 Foreshore Erosion Works

Mr David Bobridge and Mr Clinton Doake from MP Rogers addressed the meeting in respect to their foreshore erosion works proposal and answered various questions raised by elected members.

The Presiding Member thanked Mr Bobridge and Mr Doake for their attendance following which they left the meeting at 8.00pm.

# W10.1 Progress of footpath, road and kerb replacement. In particular footpath order of priority and progress across the 4 wards. Types of footpaths, cost, longevity, construction time

The Committee considered the information provided to the last Council Meeting on footpath and crossover costings, prepared by Kevin White, Council's former Operations Manager, prior to his departure.

As previously advised to elected members, the CEO confirmed that a new Operations Manager, Steve Gallaugher, has recently commenced with the Town and would be providing further information on this issue in due course.

The Works Manager answered questions raised by elected members regarding the suitability and longevity of footpath materials throughout the district.

### Mayor O'Neill - Cr Martin

That the matter be considered further at the next Committee meeting pending provision of information as requested in the Committee's 27 November 2013 resolution.

### W10.2 Proposed Traffic Island Treatments Munro/Chauncy/Habgood Streets

The CEO tabled a plan of the proposed traffic island treatments in the above streets at the intersection of Woodhouse Road.

The Works Manager advised that it had been decided to increase the extend of public consultation to involve more residents.

Cr Collinson and the Operations Manager left the meeting at 8.30pm.

Cr McPhail stated that the plan indicated concrete islands and requested consideration be given to including landscaping within the treatments.

Following a query from Cr Martin, the Executive Manager Finance & Administration advised that these works had been included in the 2013/2014 Budget which elected members had adopted.



The CEO undertook to investigate the issue of landscaping within the treatments and provide further information regarding the project, following the close of the consultation period.

### W10.3 Foreshore Erosion Works (Continued)

Mayor O'Neill - Cr McPhail

**That Council:** 

- 1. undertake construction of the reno mattress option at an estimated cost of \$50,000, as outlined in MP Rogers & Associates proposal dated February 2014
- 2. seek Swan River Trust Riverbank funding for total sand renourishment as outlined in MP Roberts & Associates proposal dated February 2014 at an estimated cost of \$150,000, in order to enhance the amenity of this area.CARRIED

### W10.4 George Street traffic counts

This issue had been raised by Cr Martin due to concerns regarding vehicle speeds in George Street.

The CEO outlined relevant information in relation to traffic counts taken between 30 January and 18 February 2014.

The data indicated general traffic speeds in George Street were low, with an almost negligible number of vehicles exceeding the 50km/hr posted speed limit.

Counters had been installed at the George Street intersection of Glyde Street, Hubble Street, Sewell Street and King Street, with the following results:

### Glyde Street

24.820 vehicles counted

Number of vehicles exceeding posted speed limit (50 km/hr) = 14 (0.05%)

Number of vehicles travelling between 40km/hr and 50km/hr = 404 (1.6%)

85% speed = 33.8km/hr

Mean speed = 28.3 km/hr.

### **Hubble Street**

38,695 vehicles counted

Number of vehicles exceeding posted speed limit (50 km/hr) = 241 (0.62%)

Number of vehicles travelling between 40km/hr and 50km/hr = 3,715 (9.6%)

85% speed = 38.2km/hr

Mean speed = 30.5 km/hr

### Sewell Street

36.760 vehicles counted

Number of vehicles exceeding posted speed limit (50 km/hr) = 136 (0.37%)

Number of vehicles travelling between 40km/hr and 50km/hr = 2,181 (5.9%)

85% speed = 36.0km/hr

Mean speed = 28.4 km/hr

### King Street

32.514 vehicles counted

Number of vehicles exceeding posted speed limit (50 km/hr) = 9 (0.03%)

Number of vehicles travelling between 40km/hr and 50km/hr = 258 (0.79%)

85% speed = 31.0km/hr

Mean speed = 24.5 km/hr

#### Cr Martin - Cr Watkins

That on the basis of the recent traffic counts undertaken, Council approach Main Road WA to request a speed limit of 40k/per hour in George Street East Fremantle.
