## Competition Terms and Conditions

By entering the Town of East Fremantle's LOOK LOCAL competition I confirm that I have read, and understood, these Terms and Conditions. I provide my consent to be bound by them, I agree to abide by them and I confirm that I am over 18 years of age.

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
3. The competition is being run by the **Town of East Fremantle**, 135 Canning Highway, East Fremantle WA 6158 ("**the Town**").
4. The **LOOK LOCAL** competition ("**the competition**") commences at midday Australian Western Standard Time (AWST) on Friday 6 September 2019.
5. The competition will be open for 6 weeks with closing time for entering the competition being 5.00pm AWST on Friday 18 October 2019.
6. Entry to the competition is limited to residents of Western Australia, aged 18 years and over.
7. To enter the competition, the entrant can:
  - i. enter online at <https://www.surveymonkey.com/r/LOOKLOCALcomp>; or
  - ii. complete a 'scratch card' at an East Fremantle shopfront (no purchase required).
8. Entry to the competition is free, however, entrants are responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
9. Entrants can submit multiple entries (to a maximum of 6).
10. There will be one (1) prize. This prize will be a collection of donated goods and services from East Fremantle businesses.
11. There will be one (1) draw at 5.30pm Australian Western Standard Time on Tuesday 22 October at East Fremantle Town Hall. The draw will be by random barrel draw from all eligible entries received with the first entry drawn being the prize winner.



12. The prize winner will be contacted within twenty-four (24) hours of the draw by the email address supplied by the entrant.
13. If the prize winner does not respond to claim the prize within twenty-one (21) days of the draw, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method. Redraws will continue in the same manner until the prize is claimed by the prize winner.
14. The prize may be collected in person by the prize winner or may be couriered.
15. If a prize winner who has been contacted and been made aware of their prize winning, and has agreed to collect the prize or for which collection is the only method for receiving the prize, does not collect the prize within twenty-one (21) days of this contact, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method.
16. The prize winner may be required to provide evidence of their identity (such as photographic ID, birth certificate or current passport) when receiving the prize.
17. The prize winner will be responsible for all costs associated with collecting and using the prize.
