Nomination Terms and Conditions

In nominating a local volunteer for acknowledgement as part of the Town of East Fremantle's VOLUNTEER WEEK 2021 promotion I confirm that I have read, and understood, these Terms and Conditions. I provide my consent to be bound by them, I agree to abide by them, and I confirm that I am over 18 years of age.

1. Instructions on how to nominate are contained within advertisements for this promotion and form part of the conditions of entry.
2. The Terms and Conditions of this promotion are governed by the laws of the State of Western Australia.
3. The promotion is being run by the **Town of East Fremantle**, 135 Canning Highway, East Fremantle WA 6158 ("**the Town**").
4. The **VOLUNTEER WEEK 2021** promotion ("**the promotion**") commences at 8.00am Australian Western Standard Time (AWST) on Friday 9 April 2021.
5. The promotion will be open for three (3) weeks with the closing time for entering the promotion being 5.00pm AWST on Friday 30 April 2021.
6. Entry to the promotion is limited to residents of Western Australia, aged 18 years and over.
7. To nominate a local community champion email events@eastfremantle.wa.gov.au with the following information:
 - Your Name
 - Nominee Name
 - Nominee Organisation
 - Nominee Email
 - Why you think they are a local hero (up to 25 words).

The nominee must be an East Fremantle resident / property owner or volunteer for an organisation based in East Fremantle.

8. Nominating is free, however, entrants are responsible for all costs associated with nominating, which may include costs associated with accessing the internet.



9. Multiple nominations can be submitted for different nominees.
10. There will be twenty-four (24) prizes. Each prize is valued at \$75, being attendance at the East Fremantle Football Club's President's Lunch on Saturday 22 May 2021.
11. There will be one (1) virtual draw at 10.00am Australian Western Standard Time on Monday 3 May 2021. Winners will be picked randomly from the nominations received (from the first twenty-four drawn).
12. Prize winners will be advised within twenty-four (24) hours of the draw via email.
13. If the prize winner does not respond to claim the prize within seven (7) days of the draw, a re-draw will be conducted within fourteen (14) days of the original draw date, in the same location, and with the same method.
14. If a prize winner who has been contacted and been made aware of their prize winning is not available to attend the lunch they may nominate a representative from the organisation (based in East Fremantle) they volunteer for to attend on their behalf.
15. By entering the promotion, the entrant agrees that they are over the age of 18 years.
16. The prize is not redeemable for cash or an alternative prize.
17. The prize winner's name will be published on the Town's website. By entering the promotion, entrants grant the Town permission to use their full name and suburb in promotional materials.
