258.1 Proposed Amalgamation of the Town of East Fremantle with the City of Fremantle By Gary Clark Acting Chief Executive Officer on 28 October 2014

PURPOSE

To consider Council's strategy in response to the Premier's announcement that the State Government has accepted the Local Government Advisory Board's recommendation that the Town of East Fremantle be amalgamated with the City of Fremantle.

BACKGROUND

The Local Government Advisory Board (LGAB) recommendations on Metropolitan Local Government Reform were released by the Premier and the Minister for Local Government on Wednesday 22nd October. The Premier advised that the State Government accepted the recommendations except for those that related to the City of Perth. He further advised that the recommendations should now be considered State Government policy.

The LGAB recommended that a new City of Fremantle be formed by an amalgamation with the Town of East Fremantle. **ATTACHMENT**

Council's current position is that it is opposed to amalgamation. This was last resolved in October 2013. In its submission to the LGAB Council advised that its "preferred course was not to amalgamate however if it was forced into amalgamation then its primary objective is to promote the best interest of the community and staff during the transition period and beyond."

Now that the LGAB's recommendations have become State Government policy it is necessary for Council to decide whether it is in the best interests of the community that they actively oppose an amalgamation or whether to engage in the amalgamation process.

The costs and benefits of amalgamation has had significant debate in recent years so it is not the purpose of this report to continue that debate. This report will discuss the implications of the two options open to Council.

Council could oppose amalgamation by actively promoting a petition to the Minister for Local Government and Communities to hold a poll. They could then campaign in an effort to ensure that enough electors turn out to vote against the amalgamation.

The petition requires 250 signatures, or at least 10% of the electors, and will need to be lodged with the Minister by the 5th December. If the petition was successful the poll would be held on the 31st January 2015. 50% of electors need to vote for the poll to be valid and more than 50% need to vote against amalgamation.

Should a poll be successful in stopping an amalgamation then there are other options open to the State Government to achieve its policy objective. They could simply make a recommendation to the LGAB for a boundary change or legislate to force the amalgamation.

Council resources, both staff and financial, are limited and it would not be feasible to conduct an anti-amalgamation campaign as well as continue to resource the amalgamation project. The project is already behind schedule due to delays with the government announcement. Any postponement of work until after a poll on 31 January 2015 would mean that we would not be ready for the amalgamation deadline of 1 July 2015. This would create a high risk to the continuity of services to the community.

Council could take the view that, given current State Government Policy, amalgamation is inevitable at some stage. Under this scenario financial and staff resources could be focussed on making the transition as smooth as possible within the time available.

This would provide the opportunity to have some influence on the outcome for the ultimate benefit of the community rather than experiencing a forced amalgamation at some time in the future. Council could start work on a Memorandum of Understanding with the City of Fremantle to seek assurances on the continuation of services and facilities that are of most value to the community.

Conclusion

The State Government policy is that the Town of East Fremantle amalgamate with the City of Fremantle. It is clear that it intends to implement that policy. If amalgamation is considered to be inevitable then Council's stated primary objective is to promote the best interest of the community and staff during the transition period and beyond.

Any Council decision to engage in the amalgamation process does not preclude members of the community from petitioning for a poll. Council can facilitate this process without actively promoting or campaigning for it.
