7 BUSINESS OF MEETING - SWAN RIVER CROSSINGS, CANNING HIGHWAY REALIGNMENT

A Special Meeting of Electors has been called in accordance with section 5.28 of the *Local Government Act 1995* in respect to the following questions:

Have the Town of East Fremantle (T of EF) been advised of the realignment of Canning Hwy to the riverside and the termination of Beach Street?

Have the T of EF been advised of the expected traffic movements into the Plympton ward as a result of this?

If T of EF are aware of two items above, did the T of EF agree to this realignment and accept the increased traffic through Plympton ward due to the reduction of eastern access to Fremantle ie 6 lane to 2 lanes?

Does the T of EF agree to publicly oppose the realignment of Canning Hwy as currently proposed by MRWA?

What course of action does T of EF propose to effectively oppose the current Swan River Crossings project and have these actions been implemented to date?
