115.2 East Fremantle Oval Recreation Precinct Community Reference Group By Jamie Douglas, Manager Planning Services on 14 June 2013

PURPOSE OF THIS REPORT

This report provides information on the outcomes of the first Community Reference Group Meeting held on Wednesday 12 June 2013 and recommends that Council endorse some proposed changes to the Terms of Reference for the Group.

OUTCOMES FROM THE MEETING

The Committee's first meeting was held at the Council offices on Wednesday 12 June 2013 at 5:30. All committee members attended except Darren Monument and Cr Nardi.

Ms Cunningham advised prior to the meeting that she was no longer able to participate in the CRG. Mr Patrick (Ms Cunningham's partner) had been an applicant for the Preston Point Ward position and was considered the next most qualified candidate to represent that ward.

On that basis Mr Hayburn was allowed to attend the meeting, technically as an observer, with future attendance subject to formal appointment by Council.

The community representative for the Plympton Ward, Fiona Winfield was elected as the Chairperson.

The members discussed the Site Analysis Report which was circulated with the CRG Meeting Agenda and invited committee member Adam Kelly from the East Fremantle Football Club to present the Club's assessment of its future needs, costing and expectations for possible future funding at the next meeting.

It was decided that;

- following meetings will be held at 6pm on the fourth Monday of each month.
- a number of minor changes should be made to the Terms of Reference. These are attached for consideration by Council.

CONCLUSION

It was a constructive first meeting with members generally displaying a genuine desire to address the issues confronting the site's future. The proposed changes which are highlighted in the attached Terms of Reference are minor in nature and do not impact upon the primary 'Role and Functions 'of the CRG, they are recommended for Council's endorsement.



The report comprises the financial results from the month of May 2013, with commentary focusing on comparisons to the year to date amended budget position.

The attached Financial Activity Statements are prepared in accordance with the amended Local Government (Financial Management) Regulations 1996; together with supporting material to provide Council with easy to understand financial information on Council activities undertaken during the financial year.

REPORT

Introduction/Comments

The following is a summary of information on the attached financial reports:

Revised Budget Forecast

The current budget forecast for the 30th June 2013 indicates a surplus of \$111,119, noting that this was the position at the time of the April 2013 report.

The history of the budget forecast is as follows; Original Budget adopted with a projected surplus of \$60,520

At the OCM 6 December 2012 part of the end of year surplus of \$15,199 was carried forward as an increase in closing funds.

At the OCM 19 March 2013 the Half Yearly Budget Review culminated in a \$153,600 decrease in closing funds.

At the OCM 16 April 2013 amendments resulted in an increase in closing funds of \$305,000.

At the OCM 21 May 2013 amendments resulted in a decrease in closing funds \$116,000.

Operating YTD Actuals

Operating Revenue 98%; is \$162,000 less than the YTD budget. (Unfavourable)

Operating Expenditure 97%; is \$245,000 less than the YTD budget. (Favourable)

After non-cash adjustments, the total operating cash forecast is \$162,000 less than the YTD budget (Unfavourable).

Operating Revenue is 2% unfavourable with year to date budget.

There is significant variance within operating revenue such as the timing of capital grant revenue items that are not claimed until completion of the associated projects. Unfavourable variances include the \$120,000 for the Plympton Parking project, and \$92,000 for the Preston Point Road roundabout awaiting final completion.

Operating Expenditure is now 3% favourable to year to date budget.

The main area of favourable variation is the Recreation and Culture program with the EF Oval master plan project in progress \$67,000, Community Events \$19,000 that occur in the last quarter. Other favourable variations relate to the activities of the outside workforce with the allocation of internal resources of labour and plant, plus materials, for pump and reticulation overhauls, foreshore maintenance, Merv Cowan Park maintenance, John Tonkin Park maintenance and Civic Garden maintenance, offset by additional Henry Jeffery oval maintenance.

The main areas for unfavourable variances in Education and Welfare were the HACC program \$33,000 which is offset by additional funds, and under Transport operations with the allocation of internal resources of labour and plant, plus materials to road maintenance, verge maintenance, street cleaning, tree pruning and drainage maintenance.

Further analytical review of the outside workforce across Transport, Recreation and Depot functions has revealed that aggregated wages, overheads and plant allocations are in line with budget, and that external materials and contractor expenses are within budget when aggregated across the same functions. There may be variations at account level however total outside workforce resources are operating within budget.

All capital activities have been set forward in the budget so that they can be easily monitored in terms of progress; hence revenues aligned with capital projects have also been set forward which presents timing differences until projects are completed.

Other details can be found in the attached notes to the financial activity statement.

Capital expenditure is \$1,942,000 less than the YTD budget (Favourable) which represents the balance of capital programs to be completed. The report provides details on individual capital works in progress as at 31 May 2013.

117.1 Request for Partial Road Closure and Acquisition of Land – Western end of Hillside Road adjoining No. 14 Angwin Street, East Fremantle

Applicant: Richard Rodic Planning and Development

PURPOSE OF THIS REPORT

The purpose of this report is to facilitate a Council decision on a request for a partial road closure of the western end of Hillside Road and acquisition of the land by the property owner of 14 Angwin Street.

BACKGROUND

The owner of 14 Angwin Street requested partial closure and acquisition of Hillside Road in 2010 and again in 2011. At the time the Chief Executive Officer advised the land owner that it was unlikely that Council would support the closure for the following main reasons:

- pedestrian use of the road including the unconstructed section;
- the possibility that Hillside Road may be constructed to intersect with Angwin Street;
 and
- lack of reasons being put forward by the applicant which outweighed the potential community benefit of keeping the road open.

The adjoining land owner made the following statements in support of the proposal:

- the unconstructed portion of Hillside Road adjoins his garden. He has taken
 responsibility for care of the area as, in his opinion, Council does not do so and left
 unattended the area would become an eyesore. Care for the area includes watering
 the vegetation and clearing rubbish;
- the owner does not believe there is any commercial value in the land for the Town;
- Hillside Road is a cul de sac for approximately a third of the length of the 14 Angwin Street property. Given the slope of the land towards Angwin Street, Hillside Road could never be continued to intersect with Angwin Street and is only ever used by the owners of 14 Angwin Street and their visitors;
- Hillside Road serves approximately 8 residential properties, allowing the closure of this portion of the street will have no impact on the function of the street with respect to all properties that gain vehicle access from Hillside Road;

- the portion of the road requested to be closed adjoins a large apartment complex (Harbour Lights). There is extensive screening by vegetation along the northern boundary and this will serve as a buffer between the lots;
- the closure of this portion of Hillside Road will enable the owner to better utilise an
 otherwise underutilised and under maintained area without compromising the amenity
 of any adjoining property, or the amenity of the wider Town of East Fremantle
 community.

Description of subject land

The subject land is:

- Crown land vested in the care and control of the Town of East Fremantle;
- part of a dedicated road approximately 180 metres in length extending between Preston Point Road and Angwin Street:
- a cul de sac ending approximately 20 metres before the intersection with Angwin Street. The remaining unconstructed portion of the road is a local reserve for open space under TPS No.3;
- a sloping grassed area with some small trees and shrubs; and
- located in the Riverside Precinct.

Statutory Considerations

Town Planning Scheme No. 3 (TPS3) – Local Scheme Reserve Open Space Land Administration Act Land Administration Regulations

Potential Impact on Public Domain

Tree in verge : Acquisition of the land by the adjoining owner may result in loss of

existing vegetation in the area. There is a substantial line of small

trees and shrubs within the southern section of the road reserve.

Streetscape : Partial closure of the road and amalgamation of the land with 14

Angwin Street may result in the area being filled and a retaining wall and fence constructed (along the Angwin Street frontage) to achieve

the same level as the garden of the existing house.

Potential Impact on Private Domain

The owner's purported reasons for wishing to acquire the land, as discussed above, are questioned.

The owner suggests firstly he is primarily motivated by a wish to keep the area tidy, however on inspection by Council officers there were no issues in that regard.

The owner also states the proposed road closure "will enable us to better utilise an otherwise underutilised and undermaintained area" without giving any indication of what he has in mind in terms of "better utilise".

The area which is used by pedestrians to access the footpath on Angwin Street from Hillside Road (see attached photos) is quite attractive and in addition to the loss of pedestrian access issue; if retaining walls, levelling etc were to be implemented it would have an arguably negative effect on the existing natural topography. It should be noted the land comprising the unconstructed road is classified in TPS No 3 as an open space reserve.

Any Relevant Previous Decisions of Council and/or History of an Issue on Site

- 26 March 2010 Request to purchase the unconstructed portion of Hillside Road and the triangular portion of land (truncation dedicated on approval of Diagram 95136 being 22 June 1998) by the land owner of 14 Angwin Street.
- 25 January 2011 Letter requesting partial closure of Hillside Road and acquisition of the land (as summarised above) from the land owner of 14 Angwin Street.
- **2 May 2011 –** Response by the Town advising that the matter will be considered and advising that the Council is unlikely to support the proposal.

CONSULTATION

Not required unless Council was to initiate formal road closure proceedings under the Land Administration Act 1997.

Site Inspection

By Town Planner on 3 May 2013

DISCUSSION

A partial closure of the western end of Hillside Road is not considered warranted for the following reasons:

- Highway Frontage Dual Coding R12.5/R40 under TPS 3 In the case of sites with frontage to Canning Highway with a dual density coding, development above the lower density coding is subject, amongst other things, to sole vehicular access being via a street other than Canning Highway. Partial closure of Hillside Road would reduce the capacity for this to occur, in the case of some existing lots;
- Future development along Canning Highway may necessitate Council needing to continue Hillside Road through to Angwin Street. Canning Highway is classified as a Primary Regional Road under the Metropolitan Region Scheme access to sites may be restricted and/or prohibited depending on the scale of development and traffic implications. It would therefore be short-sighted to remove the option of gaining vehicular or pedestrian access to these sites from Hillside Road;
- TPS No. 3 Council Reserve Open Space this area has been used as a public thoroughfare for a considerable number of years for pedestrians from Preston Point Road and other roads, to the river. At some point in the future with further development along Canning Highway, Council may determine to improve the area and formalise the access with steps and seating. Closure of the road would prevent this from occurring;
- The area of open space concerned is clean and tidy with no evidence of anti-social behaviour; and
- o Insufficient detail. Even if Council wished to entertain the proposal there has been no undertaking that the owner would be prepared to meet all costs associated with the closure and the eventual amalgamation of the land with their land. Further the applicant has indicated no awareness that the other adjoining owner(s) would need to be offered the opportunity to purchase their share of the land concerned.

Further to the above considerations the arguments put forward by the applicant in support of partial closure are not considered compelling reasons for Council to forego this land as a community asset and as a strategically important access route for future development on Canning Highway given the density coding of the adjoining sites.

It is not out of the question that the extension of Hillside Road to Angwin Street may be warranted in the long term should lots fronting Canning Highway be proposed for redevelopment.

In short, there is no financial benefit for Council involved (monies received from the applicant would go to the Crown, not Council) and a possible loss of benefit for the broader community.

In light of the above issues it is recommended that Council refuse the request for the partial road closure and acquisition of the land and that the applicant be advised that Council is therefore not prepared to initiate formal road closure proceedings for this section of Hillside Road.

RECOMMENDATION

That the request to initiate formal road closure proceedings for a partial road closure of the western end of Hillside Road and subsequent acquisition of the land be refused.

The CEO provided an update on the latest developments, including advice on the meeting with the Minister which the Mayor and himself, together with other regional Mayors and CEOs, had attended recently and a letter which the CEO had subsequently sent to the Minister seeking clarification of some comments which he made to the meeting regarding means by which he hoped to achieve more amalgamations.

117.3 Department of Sport and Recreation

The CEO advised that funding approval had been received from the Department of Sport & Recreation for a \$50,000 grant to support the development of the East Fremantle Oval Recreation Precinct Masterplan.

117.4 A/Electoral Commissioner, WA Electoral Commission

The CEO advised that the Acting Electoral Commissioner has granted approval under section 4.17(2) of the Local Government Act 1995 to defer filling the vacancy of Mayor until the 2013 ordinary elections.

117.5 Strategic Community Plan Workshop
