PURPOSE

The purpose of this report is for Council to consider a development application for alterations and additions at a residential aged care facility located at 10 (Lot 57) Windsor Road, East Fremantle.

EXECUTIVE SUMMARY

This development application proposes alterations and additions to an existing approved residential aged care facility located at 10 (Lot 57) Windsor Road, East Fremantle. The proposed development is concentrated in the western section of the site with a considerable proportion of the works concentrated inside the building. There are changes to the Windsor Road frontage and the northern wall facing the adjoining residential dwelling to the north (which was advertised to and no submissions received). The proposed development represents a small expansion of the current approved use.

A residential aged care facility is an unlisted use in the Zoning Table of Local Planning Scheme No 3, although it was previously approved for use by Council. It is a commercial use located in a residential zone with a density code of R12.5. It is surrounded by low density single dwellings with large yards to the north, south and west.

It is noted that the site is listed as A13 in *Schedule 2: Additional Use Sites and Requirements of Local Planning Scheme No 3* where it specifically mentions that "any change in the nature of use or occupancy requires the approval of the local government." Clause 5.5.1 of LPS 3 requires that *non-residential development in a residential zone shall accord with the requirements of the Scheme for residential development under the relevant density code.*

There will be significant internal changes including the addition of 6 new bedrooms and private ensuites on the ground floor, new staff areas including offices, toilets, end of trip facilities, and training rooms. Eight bedrooms will be ungraded, and a new visitor entry will be created on Windsor Road.

It is proposed to remove the existing northern crossover and the existing 2 bay carport on Windsor Road and provide 4 additional on-street parking bays on Windsor Road. Waste and service vehicles will continue to access the site via the existing southern crossover.

It is recommended that Council support the proposed alterations and additions subject to the conditions included in the final recommendation.

CONSULTATION

Advertising

The proposed development was advertised from 8 to 23 October 2025 online and to the northern neighbouring residential property. No submissions were received.

Operations

The proposed development was referred to the Town's Operations Department. Advice was provided that an application with plans must be submitted to the Operations Department and approved prior to any works being undertaken on the pedestrian footpath or the car bays in the road reserve. All stormwater from the development must be contained on site. Both requirements will be included in the final recommendation.

Water Corporation

The proposed development was referred to the Water Corporation and the following response was received.

Thank you for your email dated 7th October 2025. We offer the following comments regarding this proposal.

Water

Reticulated water is available to the subject lot. A 50mm water service exists on the property.

Wastewater

I can confirm that there is a 150mm VC sewer main running parallel along the inside of the right hand side boundary (Windsor Rd) at approx. 7.6m and is approx. 2.7m deep. The minimum distance a building can be to the centre of this sewer main is 0.6m with piling and 2.5m without piling. A site survey will be required to determine the alignment and depth of the main. Any portion of the proposed building which is within the zone of influence to sewer main may require suitable footings in accordance with our technical guidelines. Approval for works

Any works carried out in proximity to our Assets must receive prior approval by applying for an Asset Protection Risk Assessment (APRA). SITE INSPECTION

A site inspection was undertaken.

COMMENT

This development application proposes alterations and additions to an existing approved residential aged care facility located at 10 (Lot 57) Windsor Road, East Fremantle. The proposed development is concentrated in the western section of the site with a significant proportion of the works concentrated inside the building. There are changes to the Windsor Road frontage and the northern wall facing the adjoining residential dwelling to the north (which was advertised to and no submissions received). The proposed development represents a small expansion of the current approved use.

Residential aged care facility is an unlisted use in the Zoning Table of Local Planning Scheme No 3, although it was previously approved for use by Council. It is a commercial use located in a residential zone with a density code of R12.5 so is surrounded by relatively low density single dwellings with large yards.

It is noted that the site is listed as A13 in Schedule 2: Additional Use Sites and Requirements of Local Planning Scheme No 3 where it specifically mentions that "any change in the nature of use or occupancy requires the approval of the local government." Clause 5.5.1 of LPS 3 requires that non-residential development in a residential zone shall accord with the requirements of the Scheme for residential development under the relevant density code.

On the ground floor it is proposed to demolish and remove the existing main building entry and reception, internal staff areas including offices, conference room, staff room, staff toilets and end of trip facilities, internal storage areas, mechanical plant room, kitchen and dining areas and loading dock gates. On the first floor it is proposed to remove corridors, interconnecting room walls and shared bathrooms.

It is proposed to add 6 new bedrooms and private ensuites, new staff kitchen, locker room and 2 staff bathrooms, staff training room, new storage areas, modified service entry, upgraded kitchen, and an expanded resident activity area. On the first floor 8 upgraded bedrooms with private ensuites, new entry and lounge, new office, a new fire escape route and a new entry and landscaping around the entry are to be added.

The existing pedestrian footpath will be upgraded to match the existing footpath and meet the new building entry.

The façade will also be upgraded.

It is proposed to remove the existing northern crossover on Windsor Road and provide an additional 4 on-street parking bays on Windsor Road. Waste and service vehicles will continue to access the site via the existing southern crossover. It is noted that the car parking bays located on Windsor Road are public bays and are not exclusively for the use of the residential aged care facility. There is no agreement between the landowners and the Town that allows for exclusive use of the parking bays along Windsor Road by visitors and staff.



Although the applicant has provided calculations on parking provision based on the RTA Guide to Traffic Generating Developments (NSW, 2002) according to LPS 3 Schedule 10 a nursing home is required to provide 1 car bay per 5 beds and 1 car bay for every staff member present at any one time. A summary of the Town's parking requirements according to LPS 3, current and proposed parking provision on site and on the verge, as well as the car bay deficit/surplus are provided below.

It is proposed to have 15 car bays on site; 7 bays accessible from the southern entry on Gill Street, 2 car bays accessible from the northern entry on Gill Street, 6 bays accessible from the southern entry on Windsor Road and 1 loading dock (although this is not a formal car bay). There are an additional 4 car bays to be provided on Windsor Road to be added to the existing 8 car bays on the verge.

The proposed works will add 4 public parking bays on the verge but reduce on-site private bays by 2. This results in 15 on-site bays for staff and 12 public bays on the verge. Without the verge bays, the on-site parking shortfall increases from 9 to 11 bays. However, if verge bays are included in the calculation, the shortfall of 1 becomes a surplus of 1. While verge bays are not exclusively for the aged care facility, the site is the only large commercial use in the residential area. Therefore, the additional verge bays are considered to adequately support the facility's parking needs and offset the on-site requirement. Council has previously accepted this approach.

A traffic impact statement was provided that showed that there would be only minor impacts on the adjoining road network with less than 10 additional vehicle trips per hour and as a result no response is required.

Two visitor bike bays would be provided at the first floor entry and 4 staff bike bays along with staff bathrooms and lockers would also be provided to ensure alternatives to use of a car to travel to the aged care facility.

It is also noted that regular and frequent bus services are available on Canning Highway between Fremantle and Canning Bridge. There are bus stops on either side of Canning Highway heading west and east within 100 metres of the subject site that can be utilised by both staff and visitors to the facility.

An acoustic report was provided to study the impact of an intensification of the existing use noting that the subject site is adjacent to Canning Highway which is a major vehicle traffic route and subject to State Planning Policy 5.4 – Road and Rail. It is noted that compliance with the recommendations of the report in terms of construction treatments and operational measures will result in the development complying with the requirements of the Environmental Protection (Noise Regulations) 1997 and SPP 5.4.

A Waste Management Plan has been prepared in response to the proposed development. The existing waste management practices will continue to accommodate the additional waste generated by the proposed development. The loading dock will be upgraded, and a modified waste storage area will be provided adjacent to this loading dock on the ground level. A new entry gate will be added to the existing loading area accessible from Windsor Road.



Natural light and ventilation will be provided to each new room. The development is primarily within the building envelope of the existing building and is respectful of the existing streetscape and surrounding residential area. The proposed development improves the integration of the building with the street and contributes positively to the surrounding residential area and does not detract from the amenity of the neighbourhood.

As the property is located within a residential area assessment is in accordance with the Residential Design Codes. There is only 1 variation to the Residential Design Codes in relation to the primary street setback. This is explained below

Primary Street Setback

The Residential Design Codes deemed to comply clause 5.1.2 C2.1 requires that buildings are located 7.5m from the front boundary in accordance with the appropriate density code Residential R12.5. In this case the modified entry statement to the building is located between 2.51m and 3.47m from the front boundary. The reduced primary street boundary setback can be supported in accordance with design principles 5.1.2 P2.1 for the following reasons.

- The setback is consistent with an established streetscape.
- Adequate privacy and open space are provided.
- It accommodates site planning requirements such as parking, landscape, and utilities and
- Allows safety clearances for easements for essential service corridors.

There is currently a carport located in the space that is proposed to become the new visitor entry for the facility. Although there is a reduced setback from the street it is consistent with the current setback of the carport, does not reduce privacy or open space on site and allows for the creation of 4 additional car bays on the street and new landscaping around the entry area. There are no easements that are impacted by the reduced street setback. For these reasons the reduced primary street setback is recommended for support.

Advertising

The proposed development was advertised online and to the northern neighbouring property from 8 to 23 October 2025. No submissions were received.

Water Corporation Advice

The applicant responded to the referral advice by stating that a site plan showed that the development would not impact on Water Corporation assets. The Water Corporation requested that formal approval be sought for the proposed development. A condition has been included in the final recommendation that requires the proponent to submit Water Corporation approval and submit with the future building permit application. It is considered prudent to have this condition to verify that there are no issues with the proposed development and Water Corporation assets.

Trees on Site

It is noted that no trees are to be removed as a result of the proposed development.

CONCLUSION

The proposed development is intended to upgrade the residential aged care facility, increase the number of residents by a small number, improve staff facilities, and also improve the streetscape presentation of the building. The proposed development is considered relatively minor but had to be presented to Council in accordance with the requirements of A13 in Schedule 2: Additional Use Sites and Requirements of Local Planning Scheme No 3. There are no significant detrimental impacts on the surrounding neighbourhood. Based on the assessment the proposed development is recommended for support, subject to conditions.



OFFICER RECOMMENDATION

- (13) All introduced filling of earth to the lot or excavated cutting into the existing ground level of the lot, either temporary or permanent, shall be adequately controlled to prevent damage to structures on adjoining lots or in the case of fill, not be allowed to encroach beyond the lot boundaries. This shall be in the form of structurally adequate retaining walls and/or sloping of fill at the natural angle of repose and/or another method as approved by the Town.
- (14) Where this development requires that any facility or service within a street verge (street trees, footpath, crossover, light pole, drainage point or similar) is to be removed, modified, or relocated then such works must be approved by the Town and if approved, the total cost to be borne by the applicant. The Town must act reasonably and not refuse any reasonable proposal for the removal, modification or relocation of such facilities or services (including, without limitation any works associated with the proposal) which are required by another statutory or public authority.
- (15) This development approval is to remain valid for a period of 24 months from date of this approval.

- (15) A new footpath on the Town verge in the works area is to be connected seamlessly to the existing footpath network and constructed in a manner that removes any obstacles or stepped changes in levels and is installed and finished to the satisfaction of the Town.
- (16) All footpaths, kerbing, parking bays, verge works, and remediation is to be completed at the developer's cost and subject to an application being submitted with detailed engineering and landscaping plans for the approval of the Town.

From 1 January 2025 it is mandatory for STRA operators to have registered their accommodation with Department of Energy, Mining, Industry Regulation and Safety (DMIRS).

- details of how issues such as noise and anti-social behaviour would be addressed.
- waste management,
- a fire and emergency plan, and
- details of parking arrangements for guests.

Time Limit for Approval

A time limit will be imposed on the approval such that a maximum period of 12 months will be recommended as a condition of approval. This allows the Town to re-assess the proposal should there be any adverse and unforeseen outcomes from the approval of the premises as a STRA provider.

Maximum Number of Guests

The maximum number of guests will be limited to 5 people based on there being 2 queen sized beds, and a single bed located across 3 bedrooms. This will also be included as a condition in the final recommendation for approval.

Car Parking

As STRA is an unlisted use there are no specified parking standards. One on site parking bay is available and on-street parking is also available, however, it is not reserved and there can be no guarantee that spaces will be available near the proposed STRA. The maximum number of people permitted to be accommodated (5 people) imposed as a condition of approval will limit parking demand. In line with the Residential Design Codes reduced parking provision is an acceptable outcome if proposed development occurs near major transport routes. It is noted that the property is located relatively close to a bus stop on Canning Highway (under 250m in walking distance) and has the benefit of high frequency bus routes travelling in both directions to and from Fremantle Train Station and Canning Bridge Train Station. This has the potential to reduce the need for guests to have a car and therefore reduce the demand for parking.

Signage

Commercial operations in residential areas that impact on the amenity of surrounding residents should be mitigated, including matters such as excessive signage, which can create visual pollution. No signage is referred to in the development application and a condition will be recommended that does not permit signage.

Noise

Noise is a legitimate concern for surrounding residents of STRA. It is considered that the day-to-day operations of STRA should not exceed normal household levels. In this case the property managers will be able to be contacted if there are issues with noise. The management plan states that noise must be kept to a minimum.



Time Limit for Approval

A time limit of twelve months will be recommended as a condition of approval to ensure that the Town can monitor and respond to any adverse issues that may occur at the property. Applicants will have to seek re-approval prior to the expiry of the 12 month approval period.

Submissions from Advertising

One submission was received from advertising and is included below.

Owners have the ability to submit a development application for short term rental accommodation. There are no guarantees regarding the behaviour of tenants, however, a number of conditions have been included in the final recommendation which are intended to control the behaviour of disruptive tenants. If there are complaints the Town will investigate the issue. A 12 month approval period is recommended as a means to limit the approval period before re-assessment of a new development application. The Town can take action against the operators of short term rental accommodation if there are ongoing issues with regards to noise or behaviour of the tenants.

CONCLUSION

It is noted that there are multiple properties within residential zones in East Fremantle that are currently approved for use as STRA. This proposal is similar to these and represents a relatively low risk consideration based on the information supplied by the applicant/owner.

Based on the information supplied by the applicant the STRA is considered to be a land use that will have minimal impact on the amenity of nearby properties or on the neighbourhood generally providing the management plan is adhered to and matters considered in this report are addressed by way of the recommended conditions of development approval.

Based on the preceding assessment the proposed application to operate the short term rental accommodation at Unit 16 No 46 East Street, East Fremantle is recommended for support subject to the conditions included in the final recommendation.



PURPOSE

The purpose of this report is to inform Council of the intention of the Swan Yacht Club, (located at Reserve 27376 and 27377 (Lot 7771) Riverside Road, East Fremantle) to seek approval from Department of Biodiversity, Conservation and Attractions (DBCA) for a marquee tent, pop-up sea container bar and artificial turf on the western side of the existing club building.

DBCA is the decision maker for the proposed development in accordance with the *Swan and Canning Rivers Management Act 2006* and the Town is a referral agency only.

This report will provide Council with an update on actions by the Swan Yacht Club, as well as inform Council of the referral comments the Town administration will make to DBCA regarding the application.

It is noted that the Town administration provided signed support for the application form to DBCA as the landowner of property. As the leaseholder the Swan Yacht Club is the applicant.

EXECUTIVE SUMMARY

The Swan Yacht Club is seeking formal approval from DBCA for a marquee tent, pop-up sea container bar and artificial turf. The artificial turf and the marquee tent have already been installed on-site, and the pop-up sea container bar is yet to be installed. The existing and proposed structures are located in an area that has recently been landscaped following the removal of boat repair facilities at the Club, and formed part of the works described in the Master Plan that was presented to Council in July 2023. According to the Master Plan the structures are located in an area labelled for possible additional club buildings in the future.

It is recommended that Council support the proposal and recommended conditions that will be submitted to DBCA, noting that the Town is only a referral agency and the DBCA is the formal decision making authority.

SITE INSPECTION

A site inspection was undertaken, and photographs were taken and included in the attachment below.

COMMENT

The Swan Yacht Club, located at Reserve 27376 and 27377 (Lot 7771) Riverside Road, East Fremantle, is seeking approval from the Department of Biodiversity, Conservation and Attractions (DBCA) for a marquee tent, pop-up sea container bar and artificial turf on the western side of the existing club building. DBCA is the decision maker for the proposed development in accordance with the *Swan and Canning Rivers Management Act 2006* and the Town is a referral agency.

It is noted that the Town administration provided signed support for the application form as the landowner of the property, although the Swan Yacht Club (as the leaseholder) is the applicant.

The artificial turf and marquee tent have already been installed on-site, and the pop-up sea container bar is yet to be installed. Development is located on the western side of the existing club building in an area that was recently landscaped following the removal of boat repair facilities at the Club as part of the Master Plan that was brought before Council in July 2023.

This area has now been opened up through the addition of the grassed area that faces the riverfront and is suitable for events with temporary structures. The site where the marquee tent, pop-up sea container bar and artificial turf are located was marked on the Master Plan as being the future site for an expanded Club building.

The Town does not expect that the location or use of the structures will be an issue subject to compliance with the recommended conditions and advice notes that have been included in the final recommendation and in accordance with DBCA requirements. Ultimately the structures can be removed if necessary. The marquee tent is a steel frame with soft roof and walls, the sea container is portable and can be relocated quickly with a crane and truck and the artificial turf can be rolled up and moved.



Pop-Up Sea Container Bar

A converted sea container measuring 12m (length) by 2.4m (width) by 2.6m (height) is to be located on the southern end of the marquee tent. The sea container will be fitted out to become a bar to serve food and beverages. Power, water and waste will be connected to existing Club infrastructure. The structure can be relocated if necessary. The pop-up bar will operate under the Club's Operations Management Plan and hours of use will align with the Club's liquor license. The facility will be designed for seasonal and event use. The sea container will be painted and will utilise UV stable cladding on the exterior. It will have an insulated interior, servery windows with lockable shutters, and weatherproof roofing. It will require a building permit as it is a commercial space.

Artificial Turf

Approximately 450m² of artificial turf has been installed adjoining the pop-up bar location and marquee tent. It is designed to withstand high levels of foot traffic and reduce wear and tear on natural turf. The artificial turf will be UV stabilized, lead free polyethylene turf with permeable backing to allow infiltration and drainage. Crushed rock and clean sand have been placed underneath.

The Town's Operations Department provided advice that the artificial turf was not supported. It is recognised that the lack of sunlight and increased pedestrian traffic will have an impact on the natural turf. However, the use of artificial turf is not supported as it breaks down and plastics are released into the environment. It is therefore recommended that options to replace the turf be investigated that are environmentally safer.

Marquee Tent

The marquee tent measuring approximately 15m (width) by 25m (length) by 6m (height) has already been installed on site to the west of the existing club buildings.

The club has submitted documentation associated with the application that seeks temporary approval for the marquee tent structure to be used for events at the Club. The Town's environmental health officers are currently reviewing the application to ensure that the marquee tent meets the requirements of the *Health (Public Building) Regulations 1992*, the *Food Act 2008* and relevant *Food Safety Standards*.

Recommended Conditions and Advice Notes

The conditions that have been included in the final recommendation are a means to control detrimental impacts on the surrounding environment, maintain the aesthetics of the structures, and also ensure the safety and well-being of the public and Club members who visit the area. Due to the nature of the proposed development the Town is also recommending a 6 month approval period to ensure that temporary structures remain as temporary structure.

Concerns Regarding the Development

Discussions were held between the Town and DBCA concerning both the existing and proposed development. There were concerns expressed regarding the lack of a definitive date for the removal of the structures despite being referred to as temporary, and the installation of both the marquee tent and the artificial turf prior to formal approval from DBCA.

The DBCA has advised that they can only approve a temporary structures for a maximum of 6 months under the Swan and Canning River Regulations and the administration takes the view that such a term should be included in the final recommendation.

CONCLUSION

The Town is supportive of improvements and additions to the Club, subject to conditions that ensure that the surrounding environment is protected, the works are carried out in a safe manner and the proposed and actual development is in accordance with both the Town's requirements as the landowner and the statutory requirements of the Department of Biodiversity Conservation and Attractions (DBCA). It is recommended that Council support a



referral letter being sent to the DBCA regarding the proposal with conditions and advice notes that are recommended to be included in any approval granted by the DBCA.

OFFICER RECOMMENDATION

- 2. Works are to be constructed in conformity with the drawings and written information submitted on 24 September 2025, other than where varied in compliance with the conditions of any subsequent approvals.

- 4. No additional signage or advertising is approved. A separate application for signage or advertising is required to be submitted for consideration by the Town and the Department of Biodiversity, Conservation and Attractions.

Use of the sea container is not to be commenced until the Town has received an application for a Building Permit and the Building Permit (or Building Approval Certificate) issued in compliance with the conditions of the approval granted by the Department Department of Biodiversity Conservation and Attractions unless otherwise amended by the Town and of Biodiversity Conservation and Attractions.
- 6. The application for a Building Permit is to conform with the approved plans unless otherwise approved by the Town and the Department of Biodiversity Conservation and Attractions.
- 7. Changes are not to be made in respect of the approved plans under this application and those submitted with any building permit application, without those changes being specifically marked for the attention of the Town and the Department of Biodiversity, Conservation and Attractions.
- 8. Works are to be undertaken from 7am to 5pm Monday to Saturday. No work is to be undertaken on Sundays or public holidays.
- 9. The site is to be cleared of any equipment or materials upon the completion of works.
- 10. Removal of the marquee tent and the sea container shall require removal of the artificial turf and remediation of the site with the installation of alternatives (that are less environmentally harmful) in its place.
- 11. The alternative surface treatments to the artificial turf are to be investigated and discussed with the Town and DBCA prior to formal approval and installation.




Swan Yacht Club – Location

PURPOSE

To provide information to Council on the feasibility and cost implications of installing the Cyclist Boxes at:

- Preston Point Rd/Canning Highway
- Petra St/Canning Highway
- East St/Canning Highway
- Marmion St/Stirling Highway

A proposal was raised at the Annual Electors' Meeting (AEM) in January 2025 regarding this matter. Following a report to the Ordinary Council Meeting (OCM) held on 20 May 2025, Council resolved a request for information on cost implications.

This paper provides the costing information and a more detailed technical review on feasibility, to support Council in deciding whether to consider allocating funds to the proposal.

EXECUTIVE SUMMARY

This report responds to a Council resolution at the May 2025 OCM requesting costing information on the installation of Cyclist Boxes at four intersections within the Town.

Cyclist Boxes as a specific solution are not found to provide a level of benefit commensurate with the financial investment required. All intersections proposed are on higher order roads where bicycle rider safety is better supported through the provision of measures that separate bicycle riders from through traffic. Cyclist Boxes would not be the preferred solution for these intersections and are not expected to reduce risks to bicycle riders at each intersection, with the potential for new hazards to be introduced or existing ones exacerbated.

Cyclist Boxes at the proposed intersections are estimated to cost from \$200,000 to more than \$480,000 depending on the complexity. Costs provided are rough order of magnitude (ROM) cost estimates only, based on a high-level feasibility review of each intersection. The expenditure is not considered justified given the low or negative safety benefits that would result.

Active Transport interventions for pedestrians, bicycle riders and e-mobility users, should be prioritised by need. The George Street Place Plan Concept and Preston Point Road to Riverside Road Cycle Lane Link are recommended as the appropriate projects for the allocation of funds in this and the immediate upcoming financial years, providing greater capacity for improvements supporting the safety of bicycle riders within the Town. These projects will fully utilise the Town's current resourcing capability for the next 2-3 years, providing a clear foundation for future priorities to be strategically considered via the integrated corporate planning process.



BACKGROUND

In response to a decision adopted at the Annual Electors' Meeting (AEM) held on 29 January 2025 regarding measures to increase safety for bicycle riders, a report was presented to the Ordinary Council Meeting held on 20 May 2025 (pp17-28) covering the four requested interventions in the AEM motion.

Item 1 was a request to improve cycle access to Stirling Bridge. Whilst a barrier was not supported by MRWA some measures to improve the area have been agreed for implementation by the Fremantle Bridge Alliance.

Item 2 was the installation of Cyclist Boxes and was not recommended for prioritisation by officers however Council requested a report on the cost implications of installing the proposed Cyclist Boxes. This current report provides feedback on the costing and feasibility of the intersections proposed.

Item 3 requested prioritising cycle and pedestrian access along Fraser & George Streets and is currently being progressed via the current George Street Place Plan Concept.

Item 4 requested the continuation of cycle lanes along Preston Point Road. This is being progressed with a scoping study to be undertaken in 2025/26 to link the cycle lanes on Preston Point Road currently terminating at Petra Street with the Riverside Road cycle lanes. Due to safety concerns on Preston Point Road, this will also consider the Jerrat Drive route, as this is not only shorter but also presents the option for improved safety outcomes for active transport.

An identification and prioritisation process has identified the Preston Point Road to Riverside Road Cycle Lane Link as the most appropriate intervention for prioritisation to improve the safety of bicycle riders in the Town. This is due to this being located on the Long-Term Cycle Network (LTCN) and the safety data indicating it is not performing appropriately with respect to the safety of bicycle riders. This is an active project, with funding for a scoping study to be completed this financial year has been confirmed as the most appropriate project for further investigation. It is not currently funded within the Town's Long-Term Financial Plan and additional funding internal and external would need to be identified for implementation to progress.

CONSULTATION

Council was provided with a detailed briefing on the findings at the Council Forum on 7 October 2025. A similar presentation was provided to the Climate Action Reference Group on 10 November 2025.

The Town has consulted with Main Roads WA (MRWA) to ascertain whether there is support for Cyclist Boxes at the proposed intersections. A response had not been received at the time of writing, potentially as it is a complex question with the answer highly dependent on the site and any proposed solution. This complexity is demonstrated within this report.

Several local governments generously provided practical advice and current costing information to support this study.

The consolidated advice was:

- Cyclist Boxes are good to have, providing the greatest benefit when aligned to high bicycle rider numbers, and on routes with approaching cycle lanes.
- MRWA support the provision of Cyclist Boxes on key routes.
- There is a traffic signal approval process when seeking to implement the changes and LinSig modelling would be required. The modelling and design drawings costs range from \$20,000 to \$30,000.
- Where able to be accommodated within the existing traffic lanes, installation will generally require a combination of new signal poles, new signal lanterns, traffic loop relocation, signal controller updates and resurfacing (including green surfacing).



• The costs range from \$50,000-\$70,000 for two approaches, not including the costs of traffic management, or road modifications.

The Town has not undertaken any consultation on the proposals regarding Cyclist Boxes or the Preston Point Road to Riverside Road Cycle Lane Link with bicycle riders or the community at this stage. This type of consultation is most appropriate once viable options and suitable funding have been established and would be undertaken at a future stage of the project.

POLICY IMPLICATIONS

There are no Policy implications.

FINANCIAL IMPLICATIONS

The cost estimates for a complete project to install Cyclist Boxes include a number of components and are Rough Order of Magnitude (ROM) costs only. ROM estimates are preliminary and have a typical accuracy range of -25% to +75%. They are intended to provide a rough idea of the potential costs, to assist in determining feasibility and to secure initial funding allocations.

The ROM cost estimates for the installation of cyclist boxes at each signalised intersection have been compiled using the various cost components and are:

The cost of Cyclist Box installation on a single pair of approaches with the capacity to accept them are estimated, based on consultation with other local governments, to generally be in the range of \$50,000-70,000, including: traffic loop relocation; signals modification; controller re-programming; re-surfacing (including green surfacing); and line marking. Road Modifications and Traffic Management are additional costs. Extensive road modifications required at all sites to accommodate the required approach lanes to support the introduction of cyclist boxes. The sites are located on key metropolitan arterial roads. Traffic management is estimated at 20% of total project cost. This allowance may be conservative given projects would need to be completed under nightworks.

The work to evaluate the Cyclist Box options to this point has been undertaken by Town staff. This is conservatively estimated to have taken over 160 hours of officer time to date, and has required a level of external consultation and literature reviews, together with the applied knowledge and experience of the relevant staff members. Should further investigation be required this would need to be outsourced to consultants both from a resourcing perspective and also to access more specialist expertise.

STRATEGIC IMPLICATIONS

Making a street attractive to all users is a more efficient way of providing improvements, when compared to measures focussed on individual user types of active transport. Taking a more holistic approach: streets that are more attractive and safer for pedestrians are also safer for bicycle riders, and streets that are safer for bicycle riders are also safer for vehicles. In seeking to support active transport interventions for pedestrians, bicycle riders and e-



mobility scooters by need, the recommendation for the immediate allocation of resources remains on the George Street Place Plan Concept and the Preston Point Road to Riverside Road Cycle Lane Link. The former will seek active transport improvements that will also benefit cyclists, whilst the latter is prompted by the needs of cyclists and will seek to provide holistic active transport improvements.

If focusing on bicycle riders, as per the cyclist boxes proposal, sites selected for treatment to improve bicycle riders' safety should generally align with the LTCN. Accident statistics also play a crucial role in targeting sites for upgrades. Efforts to support the safety of bicycle riders within the Town are accordingly best focussed on the sections of the LTCN where safety statistics indicate that the network is not performing appropriately. This again would support the focus to be on the Preston Point Rd to Riverside Rd Link and the George Street Place Plan Concept. As these projects move to implementation phases a holistic and data-informed review will confirm the next priorities for consideration and implementation.

Items to be considered for future implementation should be considered as part of the Town's Integrated Planning Framework. Consideration should be given to improvements to key LTCN routes such as George Street/Fraser Street (expanding on the initial George Street Project), improved active transport routes to schools and civic areas, identification and improvement of other higher-demand routes. Selected projects should be prioritised into the Long-Term Financial Plan as funding opportunities become available as current priority projects are completed.

COMMENT

Cycle network upgrade planning

It is acknowledged that people want to cycle and use micromobility, such as e-scooters, and that the infrastructure to support this requires ongoing upgrade to achieve improved outcomes. This is a currently developing area of highway engineering, with Austroads (the association of Australian and NZ transport agencies) currently reviewing standards to further support planning for bicycle and micromobility device riders. Austroads and Department of Transport publications are the primary technical documents referenced by officers conducting this study.

A key requirement of best practice is to ensure that planning supports all ages and abilities of bicycle riders.

Cycle planning principles are to design routes and facilities that are:

- Direct Provide the most direct route
- Safe ensure Bicycle riders are provided with safe facilities
- Connected Enable riders to reach their destinations easily via routes that are connected across the
- Comfortable Ensure that riders of all ages and abilities can ride at a speed they are comfortable
- Attractive Provide safe and attractive surrounding that help deliver well-designed public spaces
- Adaptable Incorporate flexibility in design to accommodate changes in user needs and demand over time.

With this in mind, sites selected for treatment to improve bicycle riders' safety should generally align with the LTCN and accident statistics also play a crucial role in targeting sites for upgrades.

Suitability of Sites

It must be acknowledged that cycling in traffic lanes, whether in designated lanes or shared lanes, brings an inherent level of risk. Both the likelihood and severity of injury increases in line with the speed and volume of vehicular traffic sharing the road. As traffic speeds and volumes increase it becomes a more effective safety intervention to separate bicycle riders from the vehicular traffic and provide off-road facilities. The State Government's Principal Shared Path (PSP) program seeks to provide separated bicycle rider facilities on these routes with the program currently focussed on freeway and rail corridors.

DoT advice notes (source: Planning and Design for Active transport in Western Australia Guide, All ages and Abilities Contextual Guidance: Selecting and Designing High-Comfort Bicycle Facilities):

"Mixing with motor traffic is one of the main barriers to riding, with two of the biggest contributors to stress being vehicle speed and volume. These factors are inversely related – the stresses generated by speed are compounded by volume, and vice versa. When speeds and volumes are low,



more people feel comfortable riding in mixed traffic environments as they are able to maintain a reasonable and steady speed, feel less pressure to move over for passing motor vehicles, and experience fewer passing events. Where motor traffic is routinely above 30 km/h, or where volumes result in consistent passing events (i.e. more than 1,500 vehicles per day or congestion pressure at specific times), pressure on bike riders from passing vehicles increases perceived and actual risk and reduces comfort."

Highly confident cyclists make up 4% of the WA population and include those who ride frequently and have a high level of confidence mixing with motor traffic. The remainder of bicycle riders are more likely to preference separation, quieter streets and more separated facilities. The least confident will seek quiet streets and protection from both traffic and higher speed bicycle riders. Bicycle rider safety interventions should be focussed on those routes most bicycle riders prefer and most commonly use, rather than those preferred by vehicular traffic. The proposed intersections for interventions are on routes that would not be preferred for on-road cycling by the majority of bicycle riders, due to the high volumes and speeds of traffic sharing the road.

In assessing the sites, officers referred to the latest Austroads guidance – "Improving Austroads Guidance for Cycling and Micromobility Planning" (2025). The report is a publication of Austroads: an organisational collective of Australasian transport and traffic agencies including Main Roads Western Australia.

The report was published earlier this year to address the growing need for safe connections and infrastructure for cycling and micromobility devices such as e-scooters. The report seeks to provide improved guidance for planning suitable facilities that incorporates movement and place principles. Figure 1 is an extract from the report that allows road practitioners to determine the suitability of various cyclist interventions dependant on the nature of the environment. The traffic context for the sites has been overlain and indicates that all meet criteria where in road painted cycle lanes are **not recommended** for installation of painted cycle lanes and reinforces the unsuitability of Canning Highway and Stirling Highway as an appropriately safe route for cyclists on lane, and that appropriate measures require physical separation from traffic.

Three of the four sites have been investigated with concept designs undertaken to support the provision of the estimates requested by Council. The East Street Intersection is not signalised and therefore a Cyclist Box solution is not appropriate, and this intersection was not costed. Cyclist Boxes are a specific solution to signalised intersections, as they provide cyclists with an advanced waiting area and provide safety by making cyclists more visible to waiting motorists when signals are red. Cyclist boxes may also provide an advanced start for cyclists to allow them to enter the intersection in advance of vehicles and this requires additional bicycle signals and phasing, which has not been costed in this report.

Preston Point Rd/Canning Highway:

This location is a T-junction, and a Cyclist Box at this site would provide access for cyclists directly onto Canning Highway: a higher speed, higher volume traffic Primary Distributor where separated cycling facilities are the appropriate intervention. The volume and speed of traffic on each approach will not provide a comfortable and safe environment for the majority of cyclists to mix in-lane with traffic.

From a geometric perspective there are complexities that will require kerb and island modifications in order to incorporate an approach cycle lane (Figure 2). This would be limited to 1.5m, rather than the preferred 2m width, in order to fit within the available road reserve.

From a safety perspective the benefits of a Cyclist Box for highly skilled cyclists are outweighed by concern of providing less skilled bicycle riders with an inappropriate impression that both this section of Preston Point Road and Canning Highway are routes that are safe for the majority of bicycle riders.

The on-road route through this intersection is not part of the LTCN and there have been no recorded bicycle accidents at this intersection in the last 5 years. The LTCN route in the north-south direction is via the adjacent Staton Road, utilising the northern footpath on Canning Highway, crossing at the signals on the pedestrian phase to the southern side, and then rejoining the roadway at Council Place. Any changes at this intersection would require the approval of MRWA.

The ROM estimate is \$200,000 due to the road modification required.

Officers do not consider this to be a feasible or appropriate solution. There is the potential for increased bicycle accidents to result where bicycle riders are encouraged onto Canning Highway. It is more appropriate to encourage bicycle riders to remain on the lower order roads, aligning to routes defined on the LTCN, where speeds and volumes of traffic are generally lower, and a majority of bicycle riders are comfortable.

Petra St/Canning Highway:

The Petra Street approaches on which the Cyclist Boxes would be installed present an offset intersection. This is a legacy intersection with minimal public land available to provide a suitable upgrade to meet modern standards. This intersection does fall on the LTCN, however the on-road cycle lanes on the southern approach to Petra Street currently terminate in advance of the intersections.




Figure 3: Concept Layout of Petra Street Cyclist Boxes demonstrating increased sideswipe risk

Whilst there is sufficient road width to accommodate approach cycle lanes these would result in a significant increase in the offset of the traffic lanes at the intersection (Figure 3). There would be no full width Cyclist Box, as it would not be the intention to encourage cyclists to turn onto Canning Highway. It would need to be determined as to whether the increased offset would trigger a requirement for the Petra Street approaches to be phased independently through the signals, bringing additional costs and reducing efficiency of the signals. The intersection would continue to not be in accordance with modern standards and would introduce a number of new risks to all road users, including bicycle riders.

For signalised intersections, vehicles at the stop line intending to travel straight through should be directly facing the respective exit lane. This reduces potential sideswipe problems that present a hazard to both bicycle riders and vehicles. The installation of cycle lanes would result in drivers waiting at the stop line directly facing the opposing cycle lane and offset from the exit lane by over 7metres (an increase of 4m over the existing offset with the provision of 2 x 2 metre on-road cycle lanes). Drivers would also need to negotiate right-turning vehicles from the other direction further increasing the risks of sideswipes to bicycle riders.

This is a local route on the LTCN. There have been no recorded bicycle accidents at this intersection in the last 5 years. Cycle lanes to the south terminate in advance of the intersection, with bicycle riders of all abilities able to utilise the off-road route through the signals.

The ROM estimate is >\$210,000 due to the road modification required and the potential for a required variation to signal phasing, that has not been included in the estimate.

Officers do not consider this to be a feasible or appropriate solution. Any changes at this intersection would require the approval of MRWA and support from the City of Melville. Given the increased offset and resultant increase in the risk of sideswipe accidents this is not expected to be provided. Bicycle riders should be encouraged to utilise



footpaths as they near Canning Highway crossing on the pedestrian phases of the signalised intersection to reduce the risk through the intersection. The existing layout supports this.

East St/Canning Highway:

The East Street/Canning Highway intersection is not signalised and as such a Cyclist Box is not an applicable solution, as there are no signals at which a cyclist would be required to wait. An alternative solution would be required for this intersection.

There have been no recorded bicycle accidents at this intersection in the last 5 years and it is not on the LTCN.


Officers do not consider this to be a feasible or appropriate solution and it is not recommended for prioritisation at this time.

Marmion St/Stirling Highway:

Marmion Street carries > 6000 vehicles per day west of Stirling Highway and >10,000 to the east. It is not suitable for the majority of bicycle riders to mix within the traffic lanes, therefore approach cycle lanes would be an essential element. There would be no full width Cyclist Box, as it would not be the intention to encourage cyclists to turn onto Stirling Highway and cyclists would remain to the left of the lane.

A review of this intersection identified that there is insufficient space to incorporate the cyclist approach lanes within the currently available road surface (Figure 4). To accommodate the minimum 1.5m width cycle lanes significant modifications are required. This includes relocation of all four splitter islands, a noise attenuation wall (NW corner), a transmission power pole (NE corner), footpaths (SE and NW). In addition, the northeastern footpath would need to be removed with a new pedestrian crossing of Marmion St then required to the east near the existing bus-stop. Pedestrian crossing of Stirling Highway would be available on the southern side only. Traffic speeds and volumes on Marmion Street indicate this should be a signalised crossing increasing the costs, and there are complexities in identifying a suitable location for this.





The roadworks component ROM estimate alone is \$300,000 and does not account for service and noise barrier relocations or the provision of a new pedestrian crossing point on Marmion St.

A significant safety concern is the conflict between bicycle riders and left-turning vehicles exiting Stirling Highway. These movements are currently on an uncontrolled filter and there would inevitably be a level of conflict. Trucks stopped at the Stirling Highway lights would obstruct visibility of bicycle riders to the left-turning vehicles. This risk would be further exacerbated by encouraging bicycle riders to remain on road. The lower-risk route for bicycle riders is to utilise footpaths where the cycle lanes end, crossing Stirling Highway on the pedestrian phases of the signalised intersection, before rejoining when the cycle lanes recommence.

There have been no recorded bicycle accidents at this intersection in the last 5 years. Bicycle riders should be encouraged to select alternative routes on the adjacent LTCN links on the lower order roads, where speeds and volumes of traffic are lower, particularly during the Fremantle Road Traffic Bridge closure.

The ROM estimate for the project is >\$480,000 due to the extensive road modifications required. This does not include service relations; noise barrier relocations; or the new signalised pedestrian crossing.

Officers do not consider this to be a feasible or appropriate solution, and that it would be likely to increase risks to bicycle riders by encouraging them to mix with traffic in lane in an unsuitable environment. Any changes at this intersection would require the approval of MRWA and the support of the City of Fremantle.

CONCLUSION

The installation of Cyclist Boxes at the proposed intersections are not indicated to present clear safety benefits as they would also introduce new hazards. There is not a safety benefit to be derived that is commensurate with the expenditure required. Accordingly the proposal for Cyclist boxes are not recommended for further development at this time.

It is recommended that the Annual Elector's Motion of 29 January 2025 regarding measures to increase safety for bicycle riders has now been appropriately addressed. The various measures that were identified as being a priority are now integrated into the annual budget for 2025/26 and the Strategic Planning Framework more broadly. Approved measures include the prioritisation of the George Street Place Making Plan and the Preston Point Road to Riverside Road Cycle Lane Link.



Future projects will be considered as part of the Town's Integrated Planning Process, with consideration will be given to improvements to key LTCN routes such as George Street/Fraser Street (expanding on the initial George Street Project), improved active transport routes to schools and civic areas, identification and improvement of other higher-demand routes.

Selected future projects will be prioritised via the Integrated Planning Process and incorporated into the Long-Term Financial Plan. Allowing them to be scheduled as funding opportunities become available and as resources become available following completion of the current priority projects.

PURPOSE

The purpose of this report is to provide Council with the 2026-27 Integrated Planning, Reporting (IPR) and Budget Timetable. The Town's annual IPR process includes the development of a new Council Plan (combined Strategic Community Plan and Corporate Business Plan), a review of the Strategic Resource Plan (Long-term financial plan) and development of the Annual Budget.

EXECUTIVE SUMMARY

The Department of Local Government has announced reforms to replace the Strategic Community Plan and Corporate Business Plan with a 'Council Plan'. Regulations are being developed to include:

- Information and contents to be contained in the Council Plan
- The period a Council Plan is to cover
- When a Council Plan must be prepared, published, reviewed, modified and replaced
- Procedures to be followed in preparing, reviewing, modifying and replacing a Council Plan.

Council Members were briefed on the Council Plan model at the Concept Forum on 1 July 2025 and indicated support for this model.

BACKGROUND

The Integrated Planning and Reporting (IPR) framework is designed to articulate the community's vision, outcomes and priorities, balanced with the application and projection of finances and resources, and supported by consistent monitoring and reporting of progress.

The major components of the IPR framework are outlined below.

Council Plan

The Council Plan will be an integrated Strategic Community Plan and Corporate Business Plan that will meet legislative requirements and the IPR guidelines.

The Plan will clearly articulate the community's vision, priorities and aspirations and reflect findings from the Community Scorecard.



It will provide a clear and realistic plan to address community needs, with consideration for the role of Local Government and resourcing parameters. Based on the attached project plan, the draft Council Plan will be finalised and presented to Council in May 2026.

Strategic Resource Plan

The current Strategic Resource Plan (SRP) 2025/26 – 2034/35 was adopted at the Special Council Meeting of 24 June 2025.

The SRP is the Town's long-term financial plan which is integrated with asset funding requirements determined from the Town's Asset Management Plans.

The Forecast Financial Statements demonstrates the Town's capacity to meet short-term community and infrastructure needs as well as providing a level of asset renewal predictability in the longer term. It is revised and updated annually. The annual update will review the assumptions, take into consideration economic conditions and inflation, and use current available financial information and forecasts. For these reasons, it is not a static document. Its purpose is to provide broad financial projections to assist in making key decisions.

Revenue Strategy

The Town's Revenue Strategy 2025/26 – 2034/35 was endorsed at the Special Council Meeting of 24 June 2025.

The objectives of the Revenue Strategy are to:

- Provide a robust and considered framework for Rates categories, Minimum Rates, and Differential Rates that incorporates the following principles outlined in the Department of Local Government's Rating Policy for Local Governments:
 - Objectivity
 - Fairness and equity
 - Consistency
 - Transparency
 - Administrative efficiency
- Ensure a stable rates revenue stream for the Town from year to year.
- Deliver a stable rating price pathway for our community.
- Consider a framework for the setting of fees and charges.

Workforce Plan

The Workforce Plan is an informing strategy identifying the human resources and skills required to deliver on the medium to long-term strategic objectives.

The Workforce Plan is to be updated during 2025-26 and will capture the following:

- Profile of the current Town of East Fremantle workforce
- Assess the impact of labour market forces on the Town's current and future workforce
- Identify the workforce implications arising from the new Council Plan
- Detail strategies for addressing these implications

Annual Budget

The Annual Budget activates the Corporate Business Plan which in turn implements the Strategic Community Plan. With the introduction of the new Council Plan, the Annual Budget needs to include sufficient resourcing to fund the plan.

The Annual Budget is derived from the rolling Strategic Resource Plan and therefore Council resolution on the SRP is required prior to the adoption of the Annual Budget.

Community Workshops in February 2026 are proposed to inform the development of the Council Plan Council Workshops as proposed in this paper

STATUTORY ENVIRONMENT

Council is required to plan for the future of the district pursuant to section 5.56 of the *Local Government Act 1995* and supporting regulations.

Pursuant to section 5.4 (b) of the *Local Government Act 1995*, a Special Meeting of Council can be called by a resolution of Council.

PURPOSE

The purpose of the report is for Council to accept the evaluation and recommendation for the award of RFT01 2025-2026 Norm McKenzie Riverwall Development Tender.

EXECUTIVE SUMMARY

The Town of East Fremantle undertook an open public tender process to appoint a suitable Contractor/s to undertake the Norm McKenzie Riverwall Redevelopment project. The scope of this project includes the removal of an existing revetment located in front of the car park adjacent Norm McKenzie Reserve and replacement with a terraced block wall 20 m in length. The Works are located on the Swan River in East Fremantle, within the Town of East Fremantle.

The Town, in partnership with the Department of Biodiversity, Conservation and Attractions WA, is upgrading the existing river wall structure, improving access to the river and providing a new plaza. The Town has invested substantial planning and research to the redevelopment of the river wall structure and associated works to enhance the local area.

Three (3) Tenders were received by the deadline of the Request for Tender – Company A, B and C are identified in confidential attachment 1. The Tender submissions were reviewed by an evaluation panel consisting of a Town



Officer and a representative from each of the Department of Biodiversity, Conservation and Attractions (co-funding body), MP Rogers & Associates (Design Consultant for Riverwall).

Company B is recommended for appointment to the new Norm McKenzie Riverwall Redevelopment Contract, subject to contracting and satisfaction of outstanding clarifications and minor variations.

Further details of the evaluation are provided in the confidential Tender Evaluation Report in Attachment 1.

It is further recommended that the CEO be given delegated authority to award the Contract subject to the above conditions being met, or if required, to enter into negotiations with the second preferred respondent.

BACKGROUND

The Norm McKenzie Riverwall Project was approved in the Annual Budget for inclusion within the Town's Capital Works Program for the 2025/2026 financial year with a total project budget of \$430,000.

The tender was subject to the Caretaker Provisions during the Ordinary Local Government Elections and could not be either advertised or considered between 4 September and 19 October 2025 under the *Local Government Act* s.3.73 and Functions and General Regulations 11(1), 11(2) and 12(2).

The Request for Tender was advertised in the West Australian on Wednesday 3 September 2025 and on Tenderlink where it was opened for submissions from 3 September 2025 with an initial closing date of 4pm on 3 October 2025.

A Tender Addendum was issued on 24 September 2025 providing minutes of the Tender Site Briefing and a word version of Parts 5-9 of the RFT document to allow tenderers to complete those portions of their submission.

A tender extension was provided for two weeks with the final tender closing date being 12pm on 13 October 2025.

The Town received a total of three compliant submissions and no non-compliant submissions.

The tender evaluation was supported by the Department of Biodiversity, Conservation and Attractions and an external consultant involved in the design of the riverwall (MP Rogers and Associates). Both organisations provided a member to the evaluation panel, who along with a Town Officer as the evaluation panel chair, undertook the evaluation.

The Tender Evaluation and Recommendation Report is provided in Confidential Attachment 1.

CONSULTATION

No consultation was required during the Procurement Process for this project.

STATUTORY ENVIRONMENT

Local Government Act 1995

Local Government (Functions and General) Regulations 1996

The Local Government (Functions and General) Regulations 1996 require a local government to publicly invite tenders in accordance with the process detailed in Division 2 where the value exceed \$250,000.

POLICY IMPLICATIONS

Town of East Fremantle Purchasing Policy

FINANCIAL IMPLICATIONS

The preferred tender's tendered price is \$327,170. This is within the allocated budget for this portion of work subject to providing a reduced construction contingency.



The total project budget provided is \$430,000. A detailed Project Budget is provided in Confidential Attachment 2.

STRATEGIC IMPLICATIONS

The contract is required to deliver the Norm McKenzie Riverwall Redevelopment Project that forms part of the 2025/2026 capital works program. The project is part of the essential and ongoing asset management of the Town's Riverwalls and foreshore.

After the Tender period ended, an evaluation panel was formed comprising of one Town Officer and two external assessors. The Town's Officer was the panel chairperson. The evaluation panel assessed the submitted tenders against the following criteria:

- Contractor's Relevant Skills and Experience (20%)
- Construction Timeline (20%)
- Tenderer's Resources (20%)
- Demonstrated Understanding (30%)
- Added Value (10%)

After the Tender evaluation panel assessed the submissions, Company B was nominated as the preferred supplier for this project based on their submitted methodology, program and schedule of rates.

Company B demonstrated sufficient capability to undertake the works at the best value for money for the Town.

Company C was considered to demonstrate an equivalent capability however submitted a higher price for the works. Should negotiations with Company B not be successful, they would provide a suitable alternative.

CONCLUSION

Company B has demonstrated that it has the understanding to complete the required works for the Norm McKenzie Riverwall Redevelopment. They have performed similar works on the Swan Canning River System.

As such the Evaluation Panel recommends that Company B be awarded the contract for the Norm McKenzie Riverwall Redevelopment. In the event that a contract is not formed within 10 days, then negotiations should be commenced with Company C as a suitable alternative.

PURPOSE

The purpose of the report is for Council to accept the evaluation and recommendation for the award of RFT02 2025-2026 Riverside Road Resurfacing Tender.

EXECUTIVE SUMMARY

The Town of East Fremantle undertook an open public tender process to appoint a suitable Contractor/s to undertake the Riverside Road Resurfacing project and associated footpath works. The scope of this project is for the resurfacing of Riverside Road between the Swan Yacht Club and Wayman Road and adjacent footpaths.

Two Tenders were received by the deadline of the Request for Tender – Company A provided both tenders, one conforming and one non-conforming. The Tender submissions were reviewed by an evaluation panel consisting of two Town Officers, supported by a technical expert.

Company A's Non-conforming is recommended for appointment to the Riverside Road Resurfacing Contract, subject to contracting and satisfaction of outstanding clarifications and minor variations.

Further details of the evaluation are provided in the confidential Tender Evaluation Report in Attachment 1.

BACKGROUND

The Riverside Road Resurfacing Project was approved in the Annual Budget for inclusion within the Town's Capital Works Program for the 2025/2026 financial year with a total project budget of \$405,000.

The tender was subject to the Caretaker Provisions during the Ordinary Local Government Elections and therefore could not be either advertised or considered between 4 September and 19 October 2025 under the Local Government Act s.3.73 and Functions and General Regulations 11(1), 11(2) and 12(2).

The Request for Tender was advertised in the West Australian on Wednesday 3 September 2025 and on Tenderlink where it was opened for submissions from 3 September 2025 with an initial closing date of 4pm on 3 October 2025.

A tender extension was provided for two weeks with the final tender closing date being 12pm on 13 October 2025.

The Town received one compliant submission and one non-compliant submission from the same tenderer.

The tender evaluation was supported by an external consultant involved in the scoping of the project who provided technical advice to the evaluation panel.



The Tender Evaluation and Recommendation Report is provided in Confidential Attachment 1.

No Consultation was required during the Procurement Process for this project.

The preferred tender's tendered price is 362,340.

The total project budget provided is \$405,000 - this incorporates the road resurfacing budget of \$360,000 and the footpath replacement budget of \$45,000.

With the addition of additional site supervision and a 5% contingency the total forecast cost should the alternate tender be accepted is \$26,910 above the allocated budget.

STRATEGIC IMPLICATIONS

The contract is required to deliver the Riverside Road Resurfacing Project that forms part of the 2025/2026 capital works program. The project is part of the essential and ongoing asset management of the Town's Roads and footpaths.

Prior to consideration of this report, the CEO advised Council of a change to its recommendation, with additional information provided as follows:

Officers note that Company A proposes to complete the works in February 2026, and that this will coincide with the Fremantle Traffic Bridge Closure, as well as the final completion of the Norm McKenzie works. A requirement of the tender was to complete works by the end of January 2026. Officers sought to balance the potential for disruption during the bridge closure against the risk of Main Roads WA (MRWA) funding being lost. Accordingly, the original recommendation was to continue with the works and award the tender for completion on the revised timeframe.

Since drafting the recommendation report officers have undertaken liaison with MRWA and the Fremantle Bridge Alliance (FBA) concerning the project and the proposed schedule. In addition, the growing concern of Council with respect to significant traffic disruption during the traffic bridge closure has been noted.

MRWA have verbally confirmed that there is a mechanism to reschedule the funding to 26/27.

This would require the Town to pass in the funds for 25/26 and reapply for a combined project in 26/27 that incorporates two adjacent sections of Riverside Road as a single construction project – from Swan Yacht Club to Jerrat Drive.

This would avoid disruption during the bridge closure and allow for the contract to be combined with the 26/27 planned works on Riverside Road from Wayman Reserve to Jerrat Drive. It is expected that this would also provide improved market outcomes for the future tender.

It should be noted that the mechanism is not a deferral of funds – the funds are returned to a central pool and then reapplied for and therefore cannot be fully guaranteed. The risk of not receiving the full funds in 26/27 is considered to be low.

Discussions with FBA have confirmed that they would not seek to prevent the works from being undertaken within the bridge closure period. Noting that it will impact on traffic movements during the initial closure. Officers have noted the concern of Council regarding the impacts of the bridge closure on local traffic.

Combining the scope into a single 26/27 project provides:

- increased opportunity for both cost savings, and additional tender submissions.
- for works to occur after the bridge is completed, avoiding additional disruption during the closure period.

The Local Government (Functions and General) Regulations 1996 r18(5) states that "The local government may decline to accept any tender".

Therefore the revised Officer recommendation is presented below:

PURPOSE

Following passage of the *Local Government Amendment Act 2024*, new sections 5.99B to 5.99E of the *Local Government Act 1995* provides for local governments to make superannuation contributions for council members.

A Discussion Paper on superannuation contributions was presented to the March 2025 Concept Forum. There appeared to be an appetite to bring this matter to Council for formal consideration; however, not until after the October election.

Council is requested to consider the superannuation contribution as referred in *Superannuation Guarantee* (Administration) Act 1992 (currently 12% p.a.) for the council members, which would be applied against the amount of fees and allowances paid to Council Members (assessed to be ordinary time earnings).

EXECUTIVE SUMMARY

From 1 February 2025 all local governments had the option to resolve by absolute majority to make superannuation contributions for council members. It is now mandatory for class 1 and 2 local governments to make superannuation contributions. For class 3 and 4 local governments, the payment is optional.

Where a local government resolves to make superannuation contributions, individual council members may choose to opt out of receiving superannuation.

Summary of position: superannuation for council members

Following an amendment to the Local Government Act 1995 (Western Australia) last year, local governments may decide to make payments as a contribution to a superannuation account nominated by their council members from 1 February 2025. These superannuation contributions will be mandatory for class 1 and 2 local governments from 19 October 2025.

Where a council resolves to make superannuation contribution payments for its council members, the amount of the payment is to be the amount the council would have been required to contribute under the Commonwealth Superannuation Guarantee (Administration) Act 1992 as superannuation if the council members were employees of the local government.

t is considered the following payments to council members will be ordinary time earnings for superannuation purposes:

- · Meeting attendance fees.
- Annual allowance for mayor, president, chair, deputy mayor, deputy president and deputy chair.

t is considered the following payments will <u>NOT</u> be ordinary time earnings for superannuation purposes:

- Expenses to be reimbursed on claim, such as travel, vehicle, childcare and professional development expenses.
- · An annual allowance in lieu of reimbursement of expenses

Background

We need to look to the Superannuation Guarantee (Administration) Act 1992 to determine from the range of remuneration paid to council members in the form of allowances, fees and expense reimbursements, which would be classified "salary or wages" for the purpose of calculating superannuation contributions now provided by the Local Government Act 1995.

Based on the Commissioner's Ruling SGR 2009/2, it seems clear the following payments would be considered OTE and subject to superannuation.

- Meeting attendance fees.
- . Annual allowance for mayor, president, chair, deputy mayor, deputy president and deputy chair.

t also seems uncontroversial the following payments are not OTE:

 Expenses to be reimbursed on claim, such as travel, vehicle, childcare and professional development expenses.

This leaves us to determine how to treat an annual allowance paid in lieu of reimbursement of expenses. It is unconditional and the council member has complete discretion on if or how the allowance is spent. On the other hand, there is an expectation it will be fully expended while acting as a council member.

t is our considered view an annual allowance paid in lieu of reimbursement paid to a council member would not be OTE and therefore not subject to superannuation.

A local government or regional local government may decide, by absolute majority, instead of reimbursing council members for all of a particular type of expense, it will pay all council members, for this type of expense, an annual allowance within the range determined by the Act.

In determining the maximum annual allowance for expenses of a particular type, the Salaries and Allowances Tribunal considers a range of factors including the following:

- the intent of the allowance to reflect the extent and nature of the expenses incurred and not to result in a windfall gain for council members;
- the capacity of local governments to set allowances appropriate to their varying operational needs:
- the particular practices of local governments in the use of information and communication technology (e.g. laptop computers, iPads); and
- the varying travel requirements of council members in local governments associated with geography, isolation and other factors.

Given the strict legislative requirements and the explicit comments of the Salaries and Allowances. Tribunal where these annual allowances in lieu of reimbursement of expenses should not result in a windfall gain for council members, we consider it to be an allowance which is a predetermined amount which has been calculated to cover the estimated expense and is given with the expectation it will be fully expended in the course of the council member providing their services.

An allowance in lieu of reimbursement of expense which does not result in a windfall gain for council members would not be considered OTE and not attract superannuation contributions.

What's changing?

New provisions streamline the provision of superannuation to council members.

Following passage of the Local Government Amendment Act 2024, new sections 5.99B to 5.99E of the Local Government Act 1995 (the Act) will allow local governments to resolve by absolute majority to make superannuation contributions for council members from 1 February 2025.

Prior to this, if a local government wanted to offer superannuation to council members, it would need to become an "Eligible Local Governing Body" (ELGB) under Division 446 of the Taxation Administration Act 1953 (Cth), which requires a unanimous council resolution.

How do these changes support local governments?

Making superannuation contribution payments for council members acknowledges the significant dedication and investment of time a council member commits to their role and helps bring council members in line with the wider workforce.

The resolution process is streamlined by only requiring an absolute majority decision rather than a unanimous one. Similarly, the system set out in the Act means superannuation can be paid without needing to also address the other taxation requirements of becoming an ELGB.

This reform aims to attract and retain council members and encourage greater diversity across local governments.

Is it mandatory?

- From 1 February 2025 all local governments will have the option to resolve by absolute majority to make superannuation contributions for council members.
- From 19 October 2025, it will become mandatory for class 1 and 2 local governments to make superannuation contributions.
- For class 3 and 4 local governments, the payment will remain optional for each council to decide if they want to make superannuation contributions to council members.

Where a local government is required to, or resolves to, make superannuation contributions, individual council members may choose to opt out of receiving superannuation.

How will it work?

Superannuation contribution payments for council members will be made in addition to any other fees and allowances. These will sit outside the threshold for fees and allowances set by the Salaries and Allowances Tribunal. Council members may receive various types of fees and allowances, in accordance with the Act and the relevant determination of the Salaries and Allowance Tribunal.

The requirement to make superannuation contribution payments in respect of these fees and allowances is to be determined in accordance with Commonwealth Superannuation Guarantee (Administration) Act 1992 (SG Act) and the further guidance provided in Superannuation Guarantee Ruling SGR 2009/2.

While council members are not considered employees under the SG Act, they are to be treated in the same manner as employees of the local government for the purposes of calculating superannuation contribution payments.

Page 2

The payment is to be the same required under the SG Act. By 1 July 2025, the superannuation guarantee rate will be 12 per cent.

The superannuation contribution payment is to be paid at the same time as the remuneration of the council member is paid. In order to allow a superannuation contribution payment to be made, a council member must nominate a superannuation account from a scheme or fund to which the SG Act applies. Local governments must not make a superannuation contribution payment for a council member if they fail to nominate an eligible superannuation account before the end of the month to which the payment relates.

Local governments must not make superannuation contribution payments for council members during any period in which they are suspended under the Act. Council members are also not entitled to a superannuation contribution payment during any period in which they are not entitled to receive their fees and allowances.

Individual council members may opt out of receiving superannuation contribution payments by providing a notice in writing to the CEO.

Advance payments

If a council member is paid their fees and allowances in advance, in the event of their resignation or suspension, they will need to repay any overpaid superannuation contributions. As this typically cannot be taken from the superannuation fund, the council member will need to repay this from their own finances.

The method of calculating the amount to be repaid is specified in regulations 32B and 34AE(2) of the Local Government (Administration) Regulations 1996.

Costs

The cost of paying superannuation for council members will need to be met by each local government out of its existing budget. This cost will vary depending on what fees and allowances the Salaries and Allowances Tribunal and the Council have determined to pay to the mayor / president and councillors and how many council members there are.

Non-compliance

In the event of non-compliance with the payment of superannuation the matter may be referred to the DLGSC as regulator of the local government sector. A council member could also seek to enforce the payment of their entitlements in court.

Our local government already provides superannuation to council members. Do we have to change the way we do so?

No, but you can if you wish to.

Can our local government still opt to become an ELGB?

Yes, if you wish to do so.

A local government may resolve to become an ELGB with the consequence that council members are to be treated as employees for a range of taxation purposes, including PAYG withholding and superannuation.

A resolution to become an ELGB requires a unanimous decision of council.

Financial implications


These reforms do not have the same tax implications for councillors as resolving to PAYG withholding under Commonwealth tax law. There are Fringe Benefits Tax (FBT) implications by resolving to become an ELGB.

There are 10 Regional Road Groups (RRG) in WA, established under the , which is overseen by a State Advisory Committee (SAC). The RRGs make recommendations to the SAC regarding the Annual Local Government Roads Program for their Region and any other relevant issues.

The RRGs are comprised of elected representatives from each Local Government within the road group. Most groups are supported by a sub-group or technical committee comprised of Local Government staff. Administrative support is provided by Main Roads WA. RRGs importantly provide Local Government with a voice in how the State Government's contribution to local roads is spent. RRG members serve a vital and valuable role in ensuring road funding decisions maximise community benefits and preserve and improve the public road network across Western Australia.

The Town of East Fremantle has representation on the South-West Metropolitan Regional Road Sub Group to oversee and coordinate the regional road funding.

A delegate and a deputy is required to be appointed to the SWMRRG.

1. Objective

This policy provides a framework for recognising the service of retiring Council Members in a fair, transparent and consistent manner, consistent with the *Local Government Act 1995 (WA)* and the *Local Government (Administration) Regulations 1996 (WA)*.

2. Policy Scope

This policy applies to all Council Members of the Town of East Fremantle who are retiring following the conclusion of a full term of office.

3. Definitions

- Town means the Town of East Fremantle
- Council Member Means a person elected under the Local Government Act 1995 (WA) as a
 member of the council of the Town and includes the Mayor of the Town.
- Retirement: The conclusion of service following the expiry of a Council Member's term where the Council Member either does not seek re-election or is not re-elected.
- Gift: As defined under the Local Government Act 1995 (WA), being a disposition of property
 or the conferral of a financial benefit without adequate consideration.

4. Policy Statement

4.1 Eligibility

- 4.1.1 A retiring Council Member will receive a gift where:
 - They have completed at least one full four-year term; and
 - Their departure meets the definition of "retirement" under this policy.
- 4.1.2 A Council Member who has been disqualified from office in accordance with s2.22 of the Local Government Act 1995 (WA) will not be eligible for a gift.
 [Note: s2.22 refers to Disqualification because of convictions.]

4.2 Value of Gifts

- 4.2.1 A gift to the value of \$100 per year of service, up to a maximum of \$1,000, in accordance with Regulation 34AC.
- 4.2.2 Any council-owned property retained by a Council Member must be valued at depreciated (residual) value and counted within the prescribed limit.

4.3 Roles and Responsibilities

The ŒO will -

- Confirm eligibility when a Council Member is due to retire.
- Monitor the terms of service of individual Council Members.
- · Arrange the item of memorabilia and gift.

4.4 Presentation -

- 4.4.1 The gift will be presented by the Mayor or nominee at an ordinary or special meeting of council, or an appropriate civic recognition event.
- 4.4.2 In the event of the death of a Council Member the Town will work respectfully with the family to ensure appropriate recognition is provided in the Council Member's memory.
- 4.5 **Record-keeping –** The gift will be noted in council minutes and, if applicable, in the gifts register.

4.6 Recognition Functions

Council may hold a civic event to recognise the contribution of retiring Council Members. Expenditure must be reasonable, budgeted, and consistent with community expectations.

4.7 Review

This policy will be reviewed every four years in line with the local government election cycle, or earlier if legislative amendments require.

PURPOSE

The purpose of this report is to present to the Council the Monthly Financial Report for the month ended 30 September 2025. A Capital Works report has been incorporated into the workbook.

EXECUTIVE SUMMARY

A Monthly Financial Report workbook has been prepared to provide an overview of key financial activity.

The WA Government amended regulation 34 of the *Local Government (Financial Management) Regulations 1996* to require the Statement of Financial Activity be presented according to nature or type classification.

Regulation 35 also requires local governments to prepare a monthly Statement of Financial Position. This has now been inserted into the Monthly Financial Report.

A Capital Works Report is presented detailing committed expenditure against budgets. This report is used to assess the clearance rate of capital projects.

A monthly dashboard report on the operations of EFCP is also presented to analyse performance against budget.

BACKGROUND

Presentation of a monthly financial report to Council is both a statutory obligation and good financial management practice that:

- a. demonstrates the Town's commitment to managing its operations in a financially responsible and sustainable manner.
- b. provides timely identification of variances from budget expectations for revenues and expenditures and identification of emerging opportunities or changes in economic conditions.
- c. ensures proper accountability to the ratepayers for the use of financial resources.

Financial information that is required to be reported to Council monthly includes:

- a. operational financial performance against budget expectations.
- b. explanations for identified variances from expectations.
- c. financial position of the Town at the end of each month.



Understanding the Financials

When reading the financial information/statements, variances (deviations from budget expectations) are classified as either:

- a. Favourable variance (F)
- b. Unfavourable variance (U)
- c. Timing variance (T)

A timing variance relates to a budgeted revenue or expense that has not occurred at the time it was expected, but which is still expected to occur with the budget year. That is, the financial transaction will still occur, but just in a different month. This timing difference may require for the year-to-date budget to be amended for future periods.

A realised favourable or unfavourable variance is different to a timing variance. It represents a genuine difference between the actual and budgeted revenue or expenditure item.

A realised favourable variance on a revenue item is a positive outcome as it increases the projected budget surplus. An unfavourable variance on a revenue item has the opposite effect, resulting in a decrease to the projected budget result.

A realised favourable variance on an expenditure item may have either of two causes – one being a saving because the outcome was achieved for lesser cost, which has the effect of increasing the projected budget result. The other cause may be that the proposed expenditure may not have been undertaken and is not expected to be incurred in that financial year. Whilst this may seem positive from the financial position perspective, it may not be a positive outcome for the community if the service or project is not delivered.

If a realised favourable or unfavourable variance is material in value, a recommendation will be provided to Council to amend the budget.

CONSULTATION

Budget Managers are provided with a monthly Responsible Officer Report for review and reporting of budget variances.

STATUTORY ENVIRONMENT

Section 6.4 of the *Local Government Act 1995* and Regulation 34 of *the Local Government (Financial Management)*Regulations 1996 detail the form and way a local government is to prepare its Statement of Financial Activity.

Regulation 35 of the *Local Government (Financial Management) Regulations 1996* requires a monthly Statement of Financial Position to be prepared.

Expenditure from the municipal fund not included in the annual budget must be authorised in advance by an absolute majority decision of Council pursuant to section 6.8 of the *Local Government Act 1995*.

Fees and charges are imposed in accordance with section 6.16 of the *Local Government Act 1995*. Fees and charges imposed outside of the Annual Budget require an absolute majority decision of Council and must give local public notice of the new fees pursuant to section 6.19 of the *Local Government Act 1995*.

POLICY IMPLICATIONS

Significant Accounting Policies are adopted by Council on an annual basis. These policies are used in the preparation of the statutory reports submitted to Council.



FINANCIAL IMPLICATIONS

As part of the adopted 2025/26 Budget, Council adopted the following thresholds as levels of material variances for financial reporting:

That in accordance with regulation 34 (5) of the Local Government (Financial Management) Regulations 1996, and AASB 1031 Materiality, the level to be used in statements of financial activity in 2025/26 for reporting material variances shall be:

- a) 10% of the amended budget; or
- b) \$10,000 of the amended budget;

whichever is greater. In addition, that the material variance limit be applied to total revenue and expenditure for each Nature classification and capital income and expenditure in the Statement of Financial Activity.

STRATEGIC IMPLICATIONS

The monthly financial report is the key financial reporting mechanism to Council, to provide oversight of the financial management of the local government. This ties into the Strategic Community Plan as follows:

The Executive Summary in the workbook provides an overview of key indicators for the month. Further comments are provided below:

- Rate Notices were issued on the 28 July. The Town receipted \$5.19 million in rates and charges revenue (including rates, ESL, service charges) by the end of September, equating to 62% of total rates and charges paid. It is noted that rate notices were issued one week later than last year.
- End of year accounting process for 24/25 are continuing; last month's reported carried forward deficit of (\$225,067) has been adjusted and the amount remains (\$300,659) as at September 2025.
- As the fixed asset register has not been finalised, no itemised depreciation has been run in 25/26, although a manual entry has been applied in the Statement of Financial Activity.



- Capital works has yet to substantially commence in 25/26.
- > Town records balance sheet account movements, such as provision of employee leave, interest on lease/ROU at the end of the financial year leading to timing variance during the year, however these are not considered material.
- East Fremantle Community Park estimated expenses and incomes are presented as separate line items in statement of financial activity.
 - Other Revenue Principal Agent Arrangements
 - o Other Expenditure Principal Agent Arrangements

EFCP actual result for the period ending August 25 has been received with the net operating loss of (\$67K) against the budgeted operating loss of (\$125K). Town's accruals of incomes and expenses have been adjusted with available actuals and where actuals are not available (September 2025), the budgeted incomes and expenses have been accrued. Attachment 2 of this report contains the details of EFCP financial performance.

CONCLUSION





The current monetary policy imposed by the Reserve Bank of Australia (RBA) is driving the interest rate environment.



PURPOSE

The purpose of this report is to present to the Council the Monthly Financial Report for the month ended 31 October 2025. A Capital Works report has been incorporated into the workbook.

EXECUTIVE SUMMARY

A Monthly Financial Report workbook has been prepared to provide an overview of key financial activity.

The WA Government amended regulation 34 of the *Local Government (Financial Management) Regulations 1996* to require the Statement of Financial Activity be presented according to nature or type classification.

Regulation 35 also requires local governments to prepare a monthly Statement of Financial Position. This has now been inserted into the Monthly Financial Report.

A Capital Works Report is presented detailing committed expenditure against budgets. This report is used to assess the clearance rate of capital projects.

BACKGROUND

Presentation of a monthly financial report to Council is both a statutory obligation and good financial management practice that:

- a. demonstrates the Town's commitment to managing its operations in a financially responsible and sustainable manner.
- b. provides timely identification of variances from budget expectations for revenues and expenditures and identification of emerging opportunities or changes in economic conditions.
- c. ensures proper accountability to the ratepayers for the use of financial resources.

Financial information that is required to be reported to Council monthly includes:

- a. operational financial performance against budget expectations.
- b. explanations for identified variances from expectations.
- c. financial position of the Town at the end of each month.



Understanding the Financials

When reading the financial information/statements, variances (deviations from budget expectations) are classified as either:

- a. Favourable variance (F)
- b. Unfavourable variance (U)
- c. Timing variance (T)

A timing variance relates to a budgeted revenue or expense that has not occurred at the time it was expected, but which is still expected to occur with the budget year. That is, the financial transaction will still occur, but just in a different month. This timing difference may require for the year-to-date budget to be amended for future periods.

A realised favourable or unfavourable variance is different to a timing variance. It represents a genuine difference between the actual and budgeted revenue or expenditure item.

A realised favourable variance on a revenue item is a positive outcome as it increases the projected budget surplus. An unfavourable variance on a revenue item has the opposite effect, resulting in a decrease to the projected budget result.

A realised favourable variance on an expenditure item may have either of two causes – one being a saving because the outcome was achieved for lesser cost, which has the effect of increasing the projected budget result. The other cause may be that the proposed expenditure may not have been undertaken and is not expected to be incurred in that financial year. Whilst this may seem positive from the financial position perspective, it may not be a positive outcome for the community if the service or project is not delivered.

If a realised favourable or unfavourable variance is material in value, a recommendation will be provided to Council to amend the budget.

CONSULTATION

Budget Managers are provided with a monthly Responsible Officer Report for review and reporting of budget variances.

STATUTORY ENVIRONMENT

Section 6.4 of the *Local Government Act 1995* and Regulation 34 of *the Local Government (Financial Management)*Regulations 1996 detail the form and way a local government is to prepare its Statement of Financial Activity.

Regulation 35 of the *Local Government (Financial Management) Regulations 1996* requires a monthly Statement of Financial Position to be prepared.

Expenditure from the municipal fund not included in the annual budget must be authorised in advance by an absolute majority decision of Council pursuant to section 6.8 of the *Local Government Act 1995*.

Fees and charges are imposed in accordance with section 6.16 of the *Local Government Act 1995*. Fees and charges imposed outside of the Annual Budget require an absolute majority decision of Council and must give local public notice of the new fees pursuant to section 6.19 of the *Local Government Act 1995*.

POLICY IMPLICATIONS

Significant Accounting Policies are adopted by Council on an annual basis. These policies are used in the preparation of the statutory reports submitted to Council.



FINANCIAL IMPLICATIONS

As part of the adopted 2025/26 Budget, Council adopted the following thresholds as levels of material variances for financial reporting:

That in accordance with regulation 34 (5) of the Local Government (Financial Management) Regulations 1996, and AASB 1031 Materiality, the level to be used in statements of financial activity in 2025/26 for reporting material variances shall be:

- a) 10% of the amended budget; or
- b) \$10,000 of the amended budget;

whichever is greater. In addition, that the material variance limit be applied to total revenue and expenditure for each Nature classification and capital income and expenditure in the Statement of Financial Activity.

STRATEGIC IMPLICATIONS

The monthly financial report is the key financial reporting mechanism to Council, to provide oversight of the financial management of the local government. This ties into the Strategic Community Plan as follows:

The Executive Summary in the workbook provides an overview of key indicators for the month. Further comments are provided below:

- Rate Notices were issued on the 28 July. The Town receipted \$8.5 million in rates and charges revenue (including rates, ESL, service charges) by the end of October, equating to 69% of total rates and charges paid. It is noted that rate notices were issued one week later than last year.
- ➤ End of year accounting process for 24/25 are continuing, and net current assets of (\$300,659) is carried forward from 30 June 2025.
- As the fixed asset register has not been finalised, no itemised depreciation has been run in 25/26, although a manual entry has been applied in the Statement of Financial Activity.
- > Capital works has yet to substantially commence in 25/26. Progress is as budgeted.
- > Town records balance sheet account movements, such as provision of employee leave, interest on lease/ROU at the end of the financial year leading to timing variance during the year, however these are not considered material.



- East Fremantle Community Park estimated expenses and incomes are presented as separate line items in statement of financial activity.
 - Other Revenue Principal Agent Arrangements
 - Other Expenditure Principal Agent Arrangements

EFCP actual result for the period ending September 25 has been received with the net operating loss of (\$147K) against the budgeted operating loss of (\$155K). Town's accruals of incomes and expenses have adjusted with available actuals and where actuals are not available (October 2025), the budgeted incomes and expenses have been accrued. Attachment 2 of this report contains the details of EFCP financial performance.





The Town's investment policy precludes investing in term deposits for more than 12 months.



PURPOSE

That Council, in accordance with regulation 13(1) of the *Local Government (Financial Management) Regulations* 1996, receives the list of payments made under delegated authority for the month ending 30 September 2025.

EXECUTIVE SUMMARY

Council has an oversight role in receiving the list of payments pursuant to *Regulation 13(1) of the Local Government* (*Financial Management*) *Regulations 1996*. It is therefore recommended that Council receives the List of Accounts paid for the period 1 September to 30 September 2025, as per the summary table.

BACKGROUND

The Chief Executive Officer has delegated authority to make payments from the Municipal and Trust Accounts in accordance with budget allocations.

The Town provides payments to suppliers by electronic funds transfer, cheque, or credit card. Attached are itemised lists of all payments made under delegated authority during the said period.

The bulk of payments are processed by electronic funds transfer (EFT) with the exception of occasional reimbursements and refunds.

CONSULTATION

Nil.

STATUTORY ENVIRONMENT

Regulation 13: Local Government (Financial Management) Regulations 1996 (as amended) requires local governments to prepare a list of payments made under delegated authority to be prepared and presented to Council monthly.

A new regulation has been added to the *Local Government (Financial Management) Regulations 1996* to increase transparency and accountability in local government, through greater oversight of incidental spending.

Regulation 13A covers purchasing cards issued by local governments to their employees. Purchasing cards use a local government approved line of credit that allows for the timely payment of goods and services acquired in the ordinary course of business.



Purchasing cards include the following:

- business or corporate credit cards
- debit cards
- store cards
- fuel cards
- taxi cards

Other than debit cards, purchasing cards all require a separate payment to the card provider.

Purchasing cards do not include:

- non-reloadable gift cards these cards are not connected to a local government account or intended to be used as a means of making ordinary business transactions
- pre-loaded purchase or credit card advances these are cash advances and should be recorded and acquitted accordingly
- SmartRider cards that are centrally controlled for general use if these cards are managed under the cash advance provisions.

POLICY IMPLICATIONS

Policy 2.1.3 Purchasing. All supplier payments are approved under delegated authority pursuant to the authorisation limits outlined in Council's Purchasing Policy.

FINANCIAL IMPLICATIONS

All expenditure is incurred by authorised officers and made in accordance with the adopted Annual Budget. All amounts quoted in this report are inclusive of GST.



PURPOSE

EXECUTIVE SUMMARY

Council has an Executive role in receiving the list of payments pursuant to Regulation 13(1) of the *Local Government* (Financial Management) Regulations 1996. It is therefore recommended that Council receives the List of Accounts paid for the period 1 October to 31 October 2025, as per the summary table.

BACKGROUND

The Chief Executive Officer has delegated authority to make payments from the Municipal and Trust Accounts in accordance with budget allocations.

The Town provides payments to suppliers by electronic funds transfer, cheque, or credit card. Attached are itemised lists of all payments made under delegated authority during the said period.

The bulk of payments are processed by electronic funds transfer (EFT) with the exception of occasional reimbursements and refunds.

CONSULTATION

STATUTORY ENVIRONMENT

Regulation 13: Local Government (Financial Management) Regulations 1996 (as amended) requires local governments to prepare a list of payments made under delegated authority to be prepared and presented to Council monthly.

A new regulation has been added to the *Local Government (Financial Management) Regulations 1996* to increase transparency and accountability in local government, through greater oversight of incidental spending.

Regulation 13A covers purchasing cards issued by local governments to their employees. Purchasing cards use a local government approved line of credit that allows for the timely payment of goods and services acquired in the ordinary course of business.



Purchasing cards include the following:

- business or corporate credit cards
- debit cards
- store cards
- fuel cards
- taxi cards

Other than debit cards, purchasing cards all require a separate payment to the card provider.

Purchasing cards do not include:

- non-reloadable gift cards these cards are not connected to a local government account or intended to be used as a means of making ordinary business transactions
- pre-loaded purchase or credit card advances these are cash advances and should be recorded and acquitted accordingly
- SmartRider cards that are centrally controlled for general use if these cards are managed under the cash advance provisions.

POLICY IMPLICATIONS

Policy 2.1.3 Purchasing. All supplier payments are approved under delegated authority pursuant to the authorisation limits outlined in Council's Purchasing Policy.

FINANCIAL IMPLICATIONS

All expenditure is incurred by authorised officers and made in accordance with the adopted Annual Budget. All amounts quoted in this report are inclusive of GST.

Officer's Advice:

The closure of the bridge in early 2026 will inevitably cause traffic congestion due to reduced river crossing capacity. This may increase 'rat-running' and local congestion within the Town.

To address these challenges, the Fremantle Bridge Alliance (FBA) and Town officers have been working collaboratively since 2021 to implement measures that minimize impacts. The primary goal is to keep Stirling Highway moving, reducing delays and discouraging drivers from seeking alternative routes.

Key initiatives include:

- **Traffic Coordination:** A monthly Traffic Management Group meeting of key stakeholders, including local government representatives from both the Town and the City of Fremantle ensures holistic planning across the region.
- Walking and Cycling: the FBA are currently completing improvements to the Stirling Highway/Canning
 Highway Intersection to improve accessibility for cyclists and pedestrians, that will be completed by the end
 of January.
- Roadwork Restrictions: A "NO-GO" zone for major roadworks during the closure period.



- **Incident Response:** Formation of an Incident Management Stakeholder Group and deployment of emergency tow trucks on both sides of the bridge for rapid clearance.
- Intersection Upgrades: Extended queuing lanes at Marmion Street/Stirling Highway and a new roundabout at East Street/Marmion Street.
- **Priority Changes:** Adjustments on St Peter's Road to improve traffic flow into Sewell Street (north).
- **Public Transport Enhancements:** Increased service frequency, discounted fares, and targeted communications to encourage uptake.
- Community and Stakeholder Engagement: The FBA has a dedicated community and stakeholder engagement team that works closely with local businesses, the Town, and other stakeholders, providing regular updates to the community. The Town continues to work with them to provide support and engagement, with a presentation scheduled for the 2 December Council Forum.

These measures aim to ensure traffic continues to flow efficiently and impacts on the Town are minimised.

In addition, the Town is liaising with the City of Fremantle to coordinate communications about advocacy efforts where possible.

Advancement of further measures Council may wish to consider will need to be cognisant of any resourcing commitment such measures might incur, including potential delay of other current priorities.

Council Resolution 171811

That Council:

- 1. notes the Fremantle Traffic Bridge is scheduled for an estimated 12-month closure starting in early 2026 to allow for the construction of a new replacement bridge.
- 2. notes the closure of the Fremantle Traffic Bridge will significantly affect East Fremantle's connectivity, local businesses, and daily commute patterns. The planned bridge closure and traffic diversions through and around East Fremantle will increase travel time and congestion, which in turn will lead to traffic seeking alternative shortcuts, making normally quieter side streets less safe for walking and cycling around the Town. Businesses within East Fremantle that depend on cross-river traffic may experience reduced footfall.
- recognises the critical role of public transport and active transport (walking and cycling) in promoting equitable access, reducing traffic congestion, lowering emissions, and enhancing community health and wellbeing.
- 4. notes the suite of measures announced by the State Government on 20 October to reduce peak hour vehicle usage, however, considers further measures are required to improve the safety of the community and support the desired 'mode shift' towards public transport, cycling and walking.
- 5. advocates to the Department of Transport and Main Roads WA to urgently consider funding and delivery of the following actions:
 - 1. Safer walking and cycling routes that access Stirling Highway Bridge, including from Canning Hwy, Riverside Road and St Peters Road.
 - 2. Safer speeds on local streets, to support safe and comfortable environments for pedestrians and cyclists in the Town. For the majority of the Town, 40kmph is considered a safer speed, except for within the Town Centre, George Street and near the local schools, which require a reduction to 30kmph.



- 3. Adjustment to the available public transport, with additional bus services and a free transit zone to operate between Petra Street and Fremantle Station on a temporary basis while the closure remains.
- 4. Provision of pre-loaded SmartRiders for new public transport users, to encourage uptake.
- 5. Expedition of the previously announced signal crossing installed on Canning Highway (near Dalgety St/Windsor Rd) to enable a safer permanent solution to cross Canning Hwy, that currently relies upon crossing guards for limited hours on school days.
- 6. continues to liaise with the City of Fremantle on the Town's shared concerns regarding the safety and accessibility of our neighbouring community and businesses, as a result of the bridge closure.
- 7. engages with residents and businesses throughout the bridge closure period to understand emerging issues and opportunities to support a safer and healthier community and encourage patronage of our local businesses that may require further funding support from the Department.
